RESPONSIBILITIES OF THE TRUSTEES

Law applicable to charities in England and Wales requires that the Trustees prepare financial statements giving a true and fair view of the charity's financial activities during the year and of its financial position at the end of the year. In preparing financial statements, the Trustees should follow best practice and:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- follow applicable accounting standards without any material departures; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The Trustees are responsible for keeping accounting records, which disclose, with reasonable accuracy, the financial position of the charity, enabling them to ascertain that the financial statements comply with Charity Law, the Charity and Church Constitutions. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

RESERVES POLICY:

The Trustees have adopted a reserves policy, which they consider appropriate to enable the company to meet its developing commitments and obligations. To this end, the policy is to retain funds equivalent to approximately 2 months staff and administration costs.

PUBLIC BENEFIT STATEMENT:

The Trustees confirm that, when exercising their powers and duties, they have complied with the duty in Section 17 of the Charities Act 2011 to have due regard to Charity Commission's general guidance on public benefit.

REVIEW OF THE YEAR:

This past 12 months presented ongoing unique challenges due to Steve Percys health (Pastor of HCC), (we thank God he continued to recover well and remains well); his absences had a significant impact on Simon Davidson and Mat Martin, (who hold a dual role as Elders and Trustees), as they were mostly focused on the spiritual leadership and pastoral support of the church, meaning fulfilling Trustee obligations required additional effort. We recognised this and have strengthened the trusteeship with the appointment of Barb Verrall in September 2024.

ANNUAL PAY REVIEW (from 01/04/24)

- We awarded Steve Percy a pay rise, constituting a cost-of-living increase of 4.5%, seeing him remain on Point 6 of the pay scale.
- We awarded the cleaner a pay increase to the livingwage rate of £12/hour

FUTURE DEVELOPMENTS:

- Assign specific responsibilities to each trustee, playing to their strengths.
- Conduct a long-term property maintenance review; and categorise according to urgency and legal obligations.
- Begin planning a medium- and long-term building strategy and maintenance plan for the building fixtures and fittings. This will take into account the vision we have for using the building to serve the community and to engage with them in a variety of ways.

Pursuing Honour for Christ, Health for His Church, and Hope for our Community

- We believe God has been faithful to us throughout 24/25 and are blessed with a healthy reserve fund which we need to allocate wisely, but not be restricted by, in terms of vision. It reminds us how dependent upon Him we are and that we need to continue to -
 - Increasingly engage with the local community in a variety of ways.
 - To always proclaim, as well as demonstrate, the love of God.
 - Strive to live in such a way as to pursue:
 - Honour for Christ
 - Health for His Church
 - Hope for our Community
 - Continue to strengthen relationships with other Churches in the local area through Tameside Kingdom Partnership.
 - Manage the Charity that is Hope Community Church (Tameside & Glossop) more effectively, to enable the people that are Hope Community Church the freedom to achieve the above aims.
