Members of the committee are appointed from each of the functional areas or sections on the unit. However, all management decisions, acquisitions and expenditure are subject to the Trustees' approval by signature in the minute book.</p> <p>Committee meetings take place each month. The budget for the next financial year is set in May by the committee for approval by the mess members at a General Meeting. Direction 11 - Identify items from the analytical review of the accounts that need to be followed up for further explanation or evidence.

The Examiner found that the charity's accounting records included some journal entries, the effect of which were to reduce the charity's tangible fixed assets by £461,422. By way of explanation, the Examiner was advised that the journal entries were made to reduce the charity's tangible fixed assets for items which it was understood do not belong to the charity. However, little additional evidence was available to the Examiner to support this assertion. The journal entries were subsequently reversed whilst the matter is investigated by the charity. This investigation had not been concluded at the date of this report.
