Minutes are taken at each Committee and General meeting and circulated electronically to reach the Trustee within 10 working days of the meeting for her approval.</p> <p>As Trustee of all Service Funds at Royal Air Force College Cranwell, the Commander also has responsibility for 3 other separately run Service Fund registered charities, namely Daedalus Officers' Mess, College Hall OACTU Officers' Mess, WOS' & Sgts' Mess and a number of other sport/society/welfare funds termed 'banked funds', which are accepted charities.</p> <p>The Trust has given consideration to the major risks to which the charity is exposed and satisfied herself that systems or procedures are established in order to manage these risks. This is done through the means of a Service Funds Internal Audit Board, convened at the start of each financial year, to carry out an internal arithmetical and management audit of the charity. 


