Activities: The charity keeps local carers effectively involved in local decision making. It enables carers to give each other emotional and practical support. It promotes employment opportunities for carers. It supports more specialised local carers groups. As a wholly independent body it works together with local politicians, health and social workers and others in the interest of all local carers.
