
To preserve and protect the health of patients of Fembrookshire in need of care and cancer treatments provided by Withybush Hospital, Haverfordwest by providing and assisting in the provision of facilities, support services and equipment not normally provided by the statutory authorities.

- Our charity continues to experience a significant increase in donations this year from families of patients and from local community groups. Our main focus this year has been to support those who have fundraised on our behalf by affording them maximum publicity at local level. Having the opportunity to present their donations and meet the clinical team at Withybush Hospital has also added value to their fundraising on our behalf.
- We have continued to work closely with our informal partner (Macmillian Cancer Support advisers) to help individual patients identified by the nursing team who may be struggling with financial challenges due to their illness. This work has continued throughout the year and we continue to receive direct and anecdotal evidence that our Patient Support Grant scheme has reduced some of the stress faced by the patients in overcoming the increase costs of heating and travel to access their treatments. We remain committed to enabling those clinical team members wishing to increase personal skills and knowledge who cannot gain financial support from the local health board. The results confirm that the clinical team members have benefitted with greater awareness, confidence and knowledge which can be shared within the team.
- Following a very positive staff and patient evaluation of last years innovative three month pilot project funded by our charity which has addressed the emotive subject of hair loss due to chemotherapy we agreed to fund a two year follow on project called "Heads Up" which began in February 2024. The project has been delivered at Withybush Hospital by Cancer Hair Care who are contracted to the local health board. The initiative has consisted of nursing team training, local hairdresser training and direct interface with patients who are going through their treatment at Withybush Hospital.
- In every discussion held by the Trustees the overriding focus has been to ensure that all spending approved by our charity seeks to maximise public benefit in line with Charities Commission guidance.

As a small charity we remain focused on continuing to add value through various equipment purchases, support for personal staff development within the clinical team and forms of practical support to patients. Needs and priorities are determined through Trustee meetings held which involve senior representatives of the clinical team.

Any ad-hoc needs identified are communicated by the clinicians to our liaison officer and shared on each occasion with all trustees where their endorsement is requested and obtained.

A total of **£54,569.47** was spent during the financial year. This includes **£548.54** in charity running costs which comprised website charges, consumables, a new large charity cheque and postage.

This year we have continued to support patients who are struggling with their finances as a result of their cancer diagnosis. A total of 42 patients undergoing treatment at Withybush Hospital have accessed our **Patient Support Grant** scheme at a cost of **£15,950**. All applicants receive a written endorsement from a clinician and a Macmillian Cancer Support representative prior to approval by two trustees of our charity.

Where health board funding cannot be accessed we have supported a member of the clinical team with travel expenses to be able to attend a personal self-development module which has enhanced her skills and updated her knowledge.

Also during the year we have purchased a small number of clinical items including a "cold cap" to help reduce patient hair loss (A total of **£1,570**).

As a small charity we remain focused on continuing to add value through various equipment purchases, support for personal staff development within the clinical team and forms of practical support to patients. Needs and priorities are determined through Trustee meetings held which involve senior representatives of the clinical team.

Any ad-hoc needs identified are communicated by the clinicians to our liaison officer and shared on each occasion with all trustees where their endorsement is requested and obtained.

A total of **£28,114** was spent during the financial year. Of this total only £214 was expended on charity running costs (website charges, consummables and postage).

This year we have been able to support a total of 65 patients undergoing cancer treatment through our **Patient Support Grant** scheme at a cost of £22,215. All applicants receive a written endorsement from a clinician and a Macmillan Cancer Support representative prior to approval by two trustees of our charity.

We are contributing 50% of the salary costs over a three year period to enable a nursing team member to gain experience, additional knowledge and skills through work placement experience in centres of excellence. Through further study and work shadowing on a daily basis of an experienced **haematology team** member, vital skills and knowledge in fighting haematology illnesses are being retained at Withybush Hospital.

Where health board funding cannot be accessed we have supported two other members of the team to attend personal self- development modules which have enhanced their skills and updated knowledge

Also during the year we have purchased a small number of furnishings and equipment requested by the team. These include;

- A New Fridge
- Storage cubes for the Wig Room
- Storage boxes for wigs
- Cold packs/trolley
- Nurses stools
- A Phlebotomy chair.




