The Oxford Mastercourse took place on 8–14 April 2024 at St Edward's School, Oxford, UK.

Altogether, 31 exceptionally talented youngsters from around the world participated in the mastercourse, guided by 13 faculty members. Seven concerts, all open to the general public and free of charge, were presented at Ogston Music School at St Edward's and the Gala concert was performed at St James's Church Piccadilly. The Mastercourse also involved five masterclasses and lectures, similarly held at the Concert Hall.

The Mastercourse gathered 24 exceptionally talented youngsters from around the world. During the Mastercourse, students received individual lessons from internationally renowned violin and piano performers and pedagogues. They also participated in masterclasses, played solo with the New Virtuosi String Ensemble and together as an ensemble. They had numerous opportunities to perform in public concerts. The intensive tuition and concerts, combined with the recreational facilities created an ideal environment for significant progress and the artistic development of each student.
