**Objects:** (A) THE ADVANCEMENT OF EDUCATION, BY MEANS OF, BUT NOT EXCLUSIVELY, THE PROVISION OF TRAINING, SUPPLEMENTARY EDUCATION, ADULT LEARNING CLASSES, AND ACTIVITIES FOR MAINSTREAM EDUCATIONAL SUBJECTS; (B) THE RELIEF OF UNEMPLOYMENT FOR THE BENEFIT OF THE PUBLIC IN SUCH WAYS AS MAY BE THOUGHT FIT, INCLUDING ASSISTANCE TO FIND EMPLOYMENT; (C) TO HELP YOUNG PEOPLE, ESPECIALLY BUT NOT EXCLUSIVELY THROUGH LEISURE TIME AND RECREATIONAL ACTIVITIES, SO AS TO DEVELOP THEIR CAPABILITIES THAT THEY MAY GROW TO FULL MATURITY AS INDIVIDUALS AND AS GOOD CITIZENS; (D) THE RELIEF OF FINANCIAL HARDSHIP BY MEANS OF, BUT NOT EXCLUSIVELY, THE PROVISION OF FREE LEGAL, WELFARE AND IMMIGRATION ADVICE AND ASSISTANCE TO PERSONS WHO, THROUGH LACK OF MEANS OR ANY OTHER DISADVANTAGE, WOULD OTHERWISE BE UNABLE TO OBTAIN SUCH ADVICE; (E) TO DEVELOP THE SKILLS AND CAPACITY OF MEMBERS OF THE SOCIALLY AND ECONOMICALLY DISADVANTAGED COMMUNITY OF THE AREA OF BENEFIT IN SUCH A WAY THAT THEY ARE BETTER ABLE TO IDENTIFY AND HELP MEET THEIR NEEDS AND TO PARTICIPATE MORE FULLY IN SOCIETY.
