Constitution and Organisation

Children First Uganda Limited is a company limited by guarantee registered on 17 December 2008, number 6775383. It is a charity registered with the Charity Commissioners on 21 July 2009, number 1130627.

Objects of the Charity

The objects of the Charity are to relieve the needs of children, young people and persons who are or who have been affected by HIV/AIDS or who are otherwise in need in such ways as the Trustees shall think fit, in particular by supporting the charitable work of Children's Rights Advocacy and Lobby Mission (CALM Africa) and other organisations working with such children, young people or persons. The trustees are not aware of any detriment or harm which might arise from carrying out the Charity's objects.

Financial Results

The Charity's assets consist entirely of cash generated from the excess income raised from charitable donations over funds released to CALM (Africa). The Trustees' policy is to maximise funds paid to CALM (Africa) and to keep reserves to a minimum accordingly.

Risk Management

The Trustees have examined the major business and operational risks which charity faces and confirm that systems have been established to enable regular reports to be produced so that necessary steps can be taken to lessen risks.

ANNUAL REVIEW OF PROJECTS & ACHIEVEMENTS

FOR THE YEAR ENDED 31 DECEMBER 2023

INTRODUCTION

Throughout 2023, the Trustees of Children First Uganda have continued to provide financial support and direction to its sister Charity, CALM Africa.

We are pleased to report another successful and encouraging year in meeting the objectives and mission of both Charities.

INCOME GENERATED

In 2023 a total of £53,953 was made available to CALM Africa to fund ongoing projects, as defined in our annual Project List. Funds made available included donations from UK Sponsors for the educational support of Primary school students, donations from other external sources, which will allow some major works to be completed, along with the introduction of other initiatives which will benefit the wider community in the local area.

It is always our aim to ensure that income received is transferred at the earliest opportunity to CALM Africa's Bank in Kampala.

In addition to this, Trustees and volunteers donated a further £1,000! As always, we continue to operate with full transparency, ensuring that the continued need for regular cross checks and proof of expenditure is exercised.

A snapshot of how some of the monies transferred to CALM were spent, is shown below:

1. Staff allowances support: CFU Trustees continue to meet the allowances of key staff and, in doing so, maintained the morale of staff while delivering CALM projects and operations. This has ensured the continued success of key projects and other initiatives designed to improve the overall operation.
2. Construction of teachers' quarters: Due to the completion of construction works at the teachers' quarters, we now have accommodation for all teachers. Some minor works remain and this is ongoing as funding dictates.
3. Classrooms and Dormitory facilities for kindergarten children are now complete.
4. Sponsorship. 36 children are now supported through the Sponsorship scheme through CFU. Fees are paid into the CFU account and then paid direct to CALM Africa in time for each semester.
5. Openwork Foundation. Funding was received from this Foundation to facilitate a Skilling Project enabling 150 young adults to be trained in IT and Agricultural and Animal husbandry. A great success.
6. In November, a gift of 250 student bags was received from Herman Miller Limited, a UK Company. These bags were distributed to each child at the Jolly Mercy Learning Centre as a Christmas gift on 2 December at the Children's Christmas Party, which was funded by a member of CFU.

PLACEMENT OF LOUGHBOROUGH STUDENTS

Once again, a team from Loughborough University went on a two-weeks attachment to the Charity. They helped with teaching at the Primary School, decoration of classrooms and provided personal funding during the Outreach Programme phase.

SCHOOLS FOR UGANDA GRANT

Together with CALM Africa, CFU applied for a grant from a Charity located on the Isle of Man. We are pleased to report that the application was successful and a donation of £34,000 was received. Various projects are now being planned and these will be reported on in the next review.

SCHOOL PERFORMANCE

The CALM Africa school, JMLC, continued to perform well at the National Examinations at the end of the 2023 semesters.

LOCAL COMMUNITY TRAINING

The programme for training Prospective Parents and Parents of Children at JMLC, along with other community members continues and this is proving to be a great success. The purpose of this training was Early Childhood Development.

SUMMARY

The Trustees of Children First Uganda remain committed to supporting the people in the Wakiso District to improve the lives of vulnerable children. We remain impressed with the way CALM Africa conducts its business and interacts with CFU. This is a direct reflection on the influences and time afforded by the Trustees of CFU. In summary, we report a much improved and productive year for the Children First Uganda Charity
