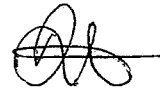

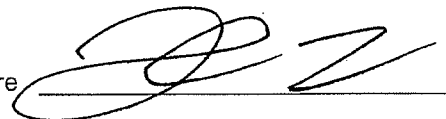

Notes to the accounts (Paras 2 to 12 are to be completed by all funds which have a gross income of £100K or over and those funds already registered with the Charity Regulator, all other funds are to complete Paras 6 and 7 and the declarations at Para 12):

1. Principal Accounting Policies

- a. Accounting Convention. The financial statements are prepared under the historical cost convention as modified by the inclusion of investments at market value and in accordance with applicable accounting standards. In preparing the financial statements the charity follows best practice as set out in the Statement of Recommended Practice "Accounting and reporting by Charities" (SORP) 2005 (<http://www.charitycommission.gov.uk/investigations/sorp/sorp05docs.asp>)
- b. Incoming Resources. Income is recognised in the period in which the charity is entitled to receipt, and the amount can be measured with reasonable certainty. Grants from other agencies including donations and other income from activities are in furtherance of the charity's objects and are part of the general funds of the charity. A restricted fund is only recognised where this is an agreed and explicit condition of the grant or donor.
- c. Intangible Income. Due to the close collaborative relationship and the manner in which the charity's activities compliment those of the Army, intangible income, reflected in time and use of premises is not quantifiable or measurable and so is not recognised in the accounts.
- d. Resources Expended and Basis of Allocation of costs. Expenditure is included when incurred or exceptionally where a commitment is made which requires an accrual when payment is to be made in the subsequent accounting period. Similarly, where prepayments are made in recognition of commitments falling due in a subsequent accounting period, the appropriate credit is entered in the accounts and reversed the following year. Grants payable are included in the SOFA when approved by the Managing Trustee. Expenditure is recognised in the period in which it is incurred. The majority of costs are directly attributable to specific activities. Irrecoverable VAT is charged to the annual report and accounts.
- e. Governance Costs. Governance costs are the costs of professional advice, holding trustee meetings or committee meetings associated with decision making, any fee for audit or independent examination and any fee incurred in the preparation, statutory filing, printing or copying of the annual report and accounts.
- f. Capitalisation and Depreciation of Tangible Fixed Assets. All assets having a purchase value of more than £500 are capitalised. The cost of tangible fixed assets are written off by equal annual instalments over their expected useful lives using the following methods of depreciation:

- Assets with a life of more than one year but with a purchase value of below £500 are included within the inventory but the cost is written off in the year it is incurred and is not depreciated over the useful life of the asset. Where the asset is depreciated over a period of more than 10 years, details of the item and period are to be provided following the notes on page 13.
- g. Fixed Asset Investment. Fixed asset investments are included at market value at the balance sheet date. Any gain or loss on revaluation is shown in the Statement of Financial Activities (SOFA) on page 2.

- h. Stocks. Purchased stocks are valued at the lower cost or net realisable value making due allowance for any obsolete or slow-moving items.
- i. Funds Accounting. Funds held by the charity are:
- (1) General Purpose/Unrestricted/Designated Funds. These are funds that can be used in accordance with the charitable objects at the discretion of the Managing Trustee. Designated funds are unrestricted funds which have been allocated/earmarked for a particular purpose by the Managing Trustee and are to be declared in the Managing Trustee's comments in accordance with Para 12 to these notes stating what they are intended to be used for and when.
 - (2) Endowment Funds. Endowment funds are those investments and other gifts accepted by the unit, the capital sum or property being held in perpetuity and the income only being available for charitable use.
 - (3) Restricted Funds. These are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes. Further explanation of the nature and purpose of each fund is to be included in the notes to the accounts.
- j. Heritage Assets. In the course of the unit's history, the charity may have acquired gifts, memorabilia, regalia, silverware, antiques and other historical artefacts in the course of distinguished military service in service of the Crown. The value of these pieces is in large part derived from their close association with Regimental history which precludes the use of conventional valuation techniques being applied. Whilst the objects of the charity do not specifically include preservation and conservation, the pieces represent an essential element of celebrating the unit's history and foster esprit-de-corps. Consequently the Managing Trustee considers the charity to hold heritage assets both for functional use and as an element of national history on behalf of the nation. Heritage assets acquired prior to 1 Apr 06 are therefore not capitalised on the balance sheet but a description of those assets is disclosed as part of the notes to the accounts. Heritage assets acquired after 1 Apr 06 where the purchase price is known and which exceed £500.00 are included in the balance sheet at acquisition value but are not depreciated.
- k. Other Costs. Other costs are those costs not incurred in the undertaking of charitable activity in furtherance of the objects of the charity, i.e. the provision of facilities, recreational programmes or activities in furtherance of military efficiency. They are also costs incurred in the making of grants and donations, in the costs of generating funds, i.e. the costs incurred in trading or fundraising undertaken by the charity, or in governance costs.

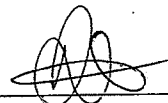

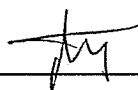

 - c. **Fund Management.** This is an active fund that is well managed and supported by the RQMS, the various Sqn SSMS, Sports Officers and various Committee members. PRI Committee Meeting are held regularly and there is full transparency about the Fund's Financial Plan.
 - d. **Accumulated General Purpose Fund (GPF).** The Balance Sheet shows an excess of income over expenditure of £5,067.06 for this financial year, resulting in a GPF value of £85,696.24 as at 31 Mar 25. This was primarily due to the underspend in sport budgets this, in spite of encouragement by the Fund Manager.
 - e. **Creditors.** The creditors are all considered current, however, the pre Jan 25 projects and entries need to be cleared as soon as possible.
 - f. **Debtors.** All debtors are current and recoverable.
 - g. **Restricted Funds - Nil Transactions.** Although there has not been any activity in the Enduro Club, Gate Guardian and RAF Central Grant Funds during the accounting period, the funds are still active.
 - h. **Sqn Funds.** The IA's aspiration of revising all of the Subunit Charters was not possible. This is now linked to the revision of the DST Financial Standing Orders by 18 Jul 25.

1. Principal Accounting Policies

- a. Accounting Convention. The financial statements are prepared under the historical cost convention as modified by the inclusion of investments at market value and in accordance with applicable accounting standards. In preparing the financial statements the charity follows best practice as set out in the Statement of Recommended Practice "Accounting and reporting by Charities" (SORP) 2005 (<http://www.charitycommission.gov.uk/investigations/sorp/sorp05docs.asp>)
- b. Incoming Resources. Income is recognised in the period in which the charity is entitled to receipt, and the amount can be measured with reasonable certainty. Grants from other agencies including donations and other income from activities are in furtherance of the charity's objects and are part of the general funds of the charity. A restricted fund is only recognised where this is an agreed and explicit condition of the grant or donor.
- c. Intangible Income. Due to the close collaborative relationship and the manner in which the charity's activities compliment those of the Army, intangible income, reflected in time and use of premises is not quantifiable or measurable and so is not recognised in the accounts.
- d. Resources Expended and Basis of Allocation of costs. Expenditure is included when incurred or exceptionally where a commitment is made which requires an accrual when payment is to be made in the subsequent accounting period. Similarly, where prepayments are made in recognition of commitments falling due in a subsequent accounting period, the appropriate credit is entered in the accounts and reversed the following year. Grants payable are included in the SOFA when approved by the Managing Trustee. Expenditure is recognised in the period in which it is incurred. The majority of costs are directly attributable to specific activities. Irrecoverable VAT is charged to the annual report and accounts.
- e. Governance Costs. Governance costs are the costs of professional advice, holding trustee meetings or committee meetings associated with decision making, any fee for audit or independent examination and any fee incurred in the preparation, statutory filing, printing or copying of the annual report and accounts.
- f. Capitalisation and Depreciation of Tangible Fixed Assets. All assets having a purchase value of more than £500 are capitalised. The cost of tangible fixed assets are written off by equal annual instalments over their expected useful lives using the following methods of depreciation:

- Assets with a life of more than one year but with a purchase value of below £500 are included within the inventory but the cost is written off in the year it is incurred and is not depreciated over the useful life of the asset. Where the asset is depreciated over a period of more than 10 years, details of the item and period are to be provided following the notes on page 13.
- g. Fixed Asset Investment. Fixed asset investments are included at market value at the balance sheet date. Any gain or loss on revaluation is shown in the Statement of Financial Activities (SOFA) on page 2.

h. Stocks. Purchased stocks are valued at the lower cost or net realisable value making due allowance for any obsolete or slow-moving items.

i. Funds Accounting. Funds held by the charity are:

(1) General Purpose/Unrestricted/Designated Funds. These are funds that can be used in accordance with the charitable objects at the discretion of the Managing Trustee. Designated funds are unrestricted funds which have been allocated/earmarked for a particular purpose by the Managing Trustee and are to be declared in the Managing Trustee's comments in accordance with Para 12 to these notes stating what they are intended to be used for and when.

(2) Endowment Funds. Endowment funds are those investments and other gifts accepted by the unit, the capital sum or property being held in perpetuity and the income only being available for charitable use.

(3) Restricted Funds. These are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes. Further explanation of the nature and purpose of each fund is to be included in the notes to the accounts.

j. Heritage Assets. In the course of the unit's history, the charity may have acquired gifts, memorabilia, regalia, silverware, antiques and other historical artefacts in the course of distinguished military service in service of the Crown. The value of these pieces is in large part derived from their close association with Regimental history which precludes the use of conventional valuation techniques being applied. Whilst the objects of the charity do not specifically include preservation and conservation, the pieces represent an essential element of celebrating the unit's history and foster esprit-de-corps. Consequently the Managing Trustee considers the charity to hold heritage assets both for functional use and as an element of national history on behalf of the nation. Heritage assets acquired prior to 1 Apr 06 are therefore not capitalised on the balance sheet but a description of those assets is disclosed as part of the notes to the accounts. Heritage assets acquired after 1 Apr 06 where the purchase price is known and which exceed £500.00 are included in the balance sheet at acquisition value but are not depreciated.

k. Other Costs. Other costs are those costs not incurred in the undertaking of charitable activity in furtherance of the objects of the charity, i.e. the provision of facilities, recreational programmes or activities in furtherance of military efficiency. They are also costs incurred in the making of grants and donations, in the costs of generating funds, i.e. the costs incurred in trading or fundraising undertaken by the charity, or in governance costs.

The Committee has remained steadfast to ensure judicious spending of the fund and has continued to support its main objectives of sporting events, welfare events and the RVS. This has led to an excess of expenditure over income of £4,439.28; due mostly to having no fixed income. Variable income has come from both restricted fund clubs such as the Clay Target Shooting Club as well as from Armex Mobile PRI Shop, who continue to support DST well. Once again, several fixed costs have been offset using ECOPF, particularly fixed licence costs. To reduce the expenditure deficit, the PRI has unanimously voted to charge subscription fees, on a pro-rata basis, beginning 1 Apr 23.

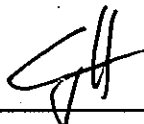
Additional comments (include any declarations which were not correct (Pg 12/13)):

The delay affected the Fund's income, but this was mitigated by resolving a potential legacy liability from the Covid-19 lockdown and the Fund Manager's close supervision of expenditure from the Fund.

I am aware of the impact that staff availability had on the Fund Manager's ability to hold the four quarterly meetings this year, which was addressed by clearing any exceptional expenditure with the Managing Trustee. I understand the tempo of business at the School and our focus on students creates challenges, but every effort must be made by Committee members to ensure that they (or a deputy) prioritise attendance at meetings, as the Fund is vital to our welfare support.

With regards to the detail of the audit report and the Internal Auditor's observations, I support the Internal Auditor's observations at page 19.

I thank the Committee and the many individuals who organise and deliver activities and events at DST for the benefit of the School.

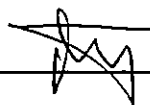

Internal Auditor's/Audit Board Report

1. I have examined the books of account and records from which the final accounts were prepared and have obtained all the information and explanations that were necessary for the purpose of my internal audit.
2. I certify that end of period checks have been conducted in accordance with Service Funds Regulations.
3. Subject to the observations given below I am satisfied that proper books of account have been kept and that the final accounts give a true and fair view of the results of transactions over the period and of the state of the Fund's affairs as at the date of the balance sheet. Subject also to my observations I am satisfied that cash and bank balances and stocks on hand have been properly checked at prescribed intervals and that adequate insurance exists.
4. I have stamped and the original books of account and the original records I have checked. All vouchers relating to this account have been cancelled.
5. I have made the following observations whilst carrying out the internal audit:
 - a. **Previous Observations.** See property below.
 - b. **Minor Internal Observations.** Minor observations have been discussed with the Fund Manager and/or the Regimental Accountant.
 - c. **Fund Management.** Unit commitments and Committee member availability has affected the frequency of PRI Committee Meeting during this Financial Year. This has been addressed by the Fund Manager and quarterly meetings have now been reinstated. The introduction of the PRI Subscriptions was also delayed, but did come into effect from 01 Apr 23.
 - d. **Accumulated General Purpose Fund (GPF).** The Balance Sheet shows an excess of expenditure over income of £4,439.28 for this financial year, resulting in a GPF value of £83,754.78 as at 31 Mar 23. The overspend was restricted by the close monitoring of expenditure by the Fund Manager and funds returned to the GPF once the legacy liability for gaming machine rental during the Covid-19 lockdown had been confirmed by the contractor.
 - e. **Creditors.** There is one creditor for an external grant. The recipient, 25 Regt RLC, has been directed to use these funds during the Financial Year 23-24.
 - f. **Debtors.** All debtors are current and recoverable, including the Lourdes Pilgrimage debt.
 - g. **Restricted Funds - Gate Guardian and 25 Trg Regt RHQ Funds.** Although there has not been any activity in these restricted funds during the accounting period, the funds are still active.
 - h. **Restricted Fund Transfers.** The transfers from the Clay Pigeon and Enduro Clubs are part of the PRI's income generation.
 - i. **Sqn Funds.** The IA has checked records supporting income and expenditure into the PRI account. In the next Financial Year the IA intends to examine the Funds' shadow records and Charters held by the individual Sqns.
 - j. **Property.** A 100% of the Fund's listed property has been conducted. The IA, Fund Manager and Property Member have discussed adding additional information regarding gifted items during 2023-24 (eg. RAF Barwood Flight).

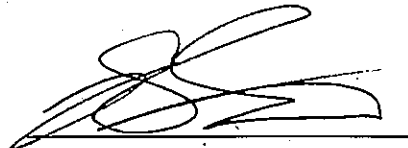

As the unit is on PAXTON only the print outs from PAXTON should be used to for the 1514s. Creating manual 1514s using the 1514 spreadsheet is pointless and a waste of time. The PAXTON prints should be inserted into correct place within the word version of the 1514s. Only 1 copy of the 1514 should be provided.

Creditor – Forces Mutual was initially received in 2020, this was received as a grant therefore the correct accounting procedure is to receive it into either a Restricted fund or into the UNR fund. I suggest for budgeting purposes a restricted fund would be best used so that the full amount of the grant can be utilised and there should not be an overspend.

Debtor balance is minimal, the correct procedure for taxi float looks as though is being followed which is commendable. The pilgrimage Lourdes debtor needs to be cleared ASAP.

1. Principal Accounting Policies

- a. Accounting Convention. The financial statements are prepared under the historical cost convention as modified by the inclusion of investments at market value and in accordance with applicable accounting standards. In preparing the financial statements the charity follows best practice as set out in the Statement of Recommended Practice "Accounting and reporting by Charities" (SORP) 2005 (<http://www.charitycommission.gov.uk/investigations/sorp/sorp05docs.asp>)
- b. Incoming Resources. Income is recognised in the period in which the charity is entitled to receipt, and the amount can be measured with reasonable certainty. Grants from other agencies including donations and other income from activities are in furtherance of the charity's objects and are part of the general funds of the charity. A restricted fund is only recognised where this is an agreed and explicit condition of the grant or donor.
- c. Intangible Income. Due to the close collaborative relationship and the manner in which the charity's activities compliment those of the Army, intangible income, reflected in time and use of premises is not quantifiable or measurable and so is not recognised in the accounts.
- d. Resources Expended and Basis of Allocation of costs. Expenditure is included when incurred or exceptionally where a commitment is made which requires an accrual when payment is to be made in the subsequent accounting period. Similarly, where prepayments are made in recognition of commitments falling due in a subsequent accounting period, the appropriate credit is entered in the accounts and reversed the following year. Grants payable are included in the SOFA when approved by the Managing Trustee. Expenditure is recognised in the period in which it is incurred. The majority of costs are directly attributable to specific activities. Irrecoverable VAT is charged to the annual report and accounts.
- e. Governance Costs. Governance costs are the costs of professional advice, holding trustee meetings or committee meetings associated with decision making, any fee for audit or independent examination and any fee incurred in the preparation, statutory filing, printing or copying of the annual report and accounts.
- f. Capitalisation and Depreciation of Tangible Fixed Assets. All assets having a purchase value of more than £500 are capitalised. The cost of tangible fixed assets are written off by equal annual instalments over their expected useful lives using the following methods of depreciation:

- Assets with a life of more than one year but with a purchase value of below £500 are included within the inventory but the cost is written off in the year it is incurred and is not depreciated over the useful life of the asset. Where the asset is depreciated over a period of more than 10 years, details of the item and period are to be provided following the notes on page 13.
- g. Fixed Asset Investment. Fixed asset investments are included at market value at the balance sheet date. Any gain or loss on revaluation is shown in the Statement of Financial Activities (SOFA) on page 2.

h. Stocks. Purchased stocks are valued at the lower cost or net realisable value making due allowance for any obsolete or slow-moving items.

i. Funds Accounting. Funds held by the charity are:

(1) General Purpose/Unrestricted/Designated Funds. These are funds that can be used in accordance with the charitable objects at the discretion of the Managing Trustee. Designated funds are unrestricted funds which have been allocated/earmarked for a particular purpose by the Managing Trustee and are to be declared in the Managing Trustee's comments in accordance with Para 12 to these notes stating what they are intended to be used for and when.

(2) Endowment Funds. Endowment funds are those investments and other gifts accepted by the unit, the capital sum or property being held in perpetuity and the income only being available for charitable use.

(3) Restricted Funds. These are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes. Further explanation of the nature and purpose of each fund is to be included in the notes to the accounts.

j. Heritage Assets. In the course of the unit's history, the charity may have acquired gifts, memorabilia, regalia, silverware, antiques and other historical artefacts in the course of distinguished military service in service of the Crown. The value of these pieces is in large part derived from their close association with Regimental history which precludes the use of conventional valuation techniques being applied. Whilst the objects of the charity do not specifically include preservation and conservation, the pieces represent an essential element of celebrating the unit's history and foster esprit-de-corps. Consequently the Managing Trustee considers the charity to hold heritage assets both for functional use and as an element of national history on behalf of the nation. Heritage assets acquired prior to 1 Apr 06 are therefore not capitalised on the balance sheet but a description of those assets is disclosed as part of the notes to the accounts. Heritage assets acquired after 1 Apr 06 where the purchase price is known and which exceed £500.00 are included in the balance sheet at acquisition value but are not depreciated.

k. Other Costs. Other costs are those costs not incurred in the undertaking of charitable activity in furtherance of the objects of the charity, i.e. the provision of facilities, recreational programmes or activities in furtherance of military efficiency. They are also costs incurred in the making of grants and donations, in the costs of generating funds, i.e. the costs incurred in trading or fundraising undertaken by the charity, or in governance costs.

This year has been focused on what could be achieved as the unit endeavoured to return to a form of normal following the relaxation of Covid-19 restrictions, cognizant of the need to replace its lost gaming machine income. This will see the introduction of a PRI Subscription for the military permanent staff in the next financial year, in order to continue to provide support and opportunities for personnel.

With regards to the detail of the audit report and the Internal Auditor's observations:

- a. I support the Internal Auditor's observations at page 19.
- b. Now that the Covid-19 restrictions have been lifted the PRI Committee is to hold its quarterly meetings, to maintain the principles of shared ownership and transparency.
- c. The Bde Gainshare funding must be taken into account during the development of the DST Forecast of Events.
- d. The final account for TSA's gaming machine hire must be confirmed as a priority.

Looking ahead, the next financial year will see several changes to the way DST will manage its Service Charitable Funds (formerly Service Non-Public Funds) as a result of the PACR recommendations. These will need to be introduced cooperatively with the RAO Department and the impact on support to external activities taken into account (eg, the RLC Military Skills Competition).

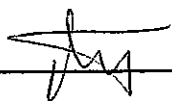

Internal Auditor's/Audit Board Report

1. I have examined the books of account and records from which the final accounts were prepared and have obtained all the information and explanations that were necessary for the purpose of my internal audit.
2. I certify that end of period checks have been conducted in accordance with Service Funds Regulations.
3. Subject to the observations given below I am satisfied that proper books of account have been kept and that the final accounts give a true and fair view of the results of transactions over the period and of the state of the Fund's affairs as at the date of the balance sheet. Subject also to my observations I am satisfied that cash and bank balances and stocks on hand have been properly checked at prescribed intervals and that adequate insurance exists.
4. I have stamped and the original books of account and the original records I have checked. All vouchers relating to this account have been cancelled.
5. I have made the following observations whilst carrying out the internal audit:
 - a. **Previous Observations.** There are no outstanding observations.
 - b. **Minor Internal Observations.** Minor observations have been discussed with the Fund Manager and/or the Regimental Accountant.
 - c. **Fund Management.** The Fund Managers have been proactive in the way they have carried out their duties. For reasons beyond the Fund Manager's control a PRI Meeting had to be delayed and this will now take place early in the next financial year. One key task that the Fund Manager has been dealing with this year has been the introduction of a PRI Subscription for military permanent staff.
 - d. **Accumulated General Purpose Fund (GPF).** The Balance Sheet shows an excess of expenditure over income of £8,573.66 for this financial year. This is due to the removal of the PRI's former main source of income, the gaming machines, whilst still supporting its fund and welfare obligations. The excess of expenditure was offset by the Committee this year through the receipt of income generation (£1920.50) funding and Capital property (£2,170.00) from the Clay Pigeon restricted fund. This income generation has been adopted as an annual income generation stream, alongside the introduction of military permanent staff subscriptions and ARMEX Mobile PRI commission.
 - e. **Creditors.** All of the creditors are considered current. The ARMEX entry will be cleared as soon as the Regimental Accountant receives the statement to support the bank transfer. The Forces Mutual, LS&GC and RAF entries are all for incomplete projects. It is recommended that these are reviewed, as some have been on-going for more than 9 months. The TSA Gaming Machine Debt is monies set a side to cover potential gaming machine rental on the termination of the contract during Covid-19. The amount that the PRI owes to TSA needs to be confirmed and any outstanding payments made to them. If the contract was terminated without incurring any further charges then these Funds (£3,186.80) can be returned to the GPF.
 - f. **Debtors.** All of the debtors are current. Post audit the 25 Regt RHQ ceased operating a float.
 - g. **Restricted Funds - Gate Guardian Funds.** Although there has not been any activity in this restricted funds during the accounting period, the funds is still active.
 - h. **Restricted Fund - Bde Gainshare.** It is recommended that the PRI Committee still consider using this fund for events in 22/23 before committing PRI GPF monies.

i. **Barwood Flight Property.** During the year the RAF Barwood Flight purchased property using external funding. It is recommended that these items are brought on to the PRI Property Book prior to the next physical check. The Fund Manager has nominated the Sp Sqn SQMS as the Project Officer for this task.
