

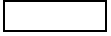



The charity commission's guidance on the public benefit of activities is kept in mind by the trustees when planning the annual activities calendar. Our activities are planned around promoting participation in tennis for all ages by offering a programme of coaching, social and competitive play throughout the year.

This helps to develop as broad a spectrum of players as possible because we welcome all regardless of age, gender, physical ability or personal circumstances.

We have a welcome all policy with equipment available for use. We provide the opportunity to play at other venues. We believe this encourages participation in sport for as many people as possible.

Junior Tennis:

The club promotes a coaching programme for juniors aged from 3 years to 18. This takes place in the form of 6 hourly slots, 3 times per year during Spring, Summer and Autumn.

In addition the club runs 6 Junior Teams that compete in a local league. The club has links with several local schools, providing coaching within the school day as well as breakfast and after school clubs.

We had our first junior inter club tournament in 2014 with a finals day and presentation evening, this is a very popular with the children and families and is now an annual event.

Senior Tennis:

We promote a coaching programme for all seniors both members and non-members in the same format as the juniors.

We have 6 competitive teams.

Members of the U3A have weekly coaching sessions

Outside the inter-club match season, there is social club tennis on most evenings of the week including ladies' doubles, men's doubles, mixed doubles and beginner's doubles all of which are very well attended.

Tournaments comprising both doubles and singles are held from time to time at weekends.

Senior members can and do use the facility at any time other than matches or coaching.

Members of the public can buy access to the courts from the local post

office.

We acknowledge and are grateful for the help of our coaches and members in enabling the large variety of programmes to run successfully throughout the year.

The coaches work hard with the committee to professionalise the club and put in a service above and beyond.

Summary of the main achievements of the charity during the year**Spring**

We run early season competitive play under floodlights which proves to be very popular with the senior members and is good preparation for the league matches.

Our main competitive playing season starts in April for 6 senior and 6 junior teams playing in the Southport and District League.

Junior and senior coaching programmes are very well attended and development takes place all year round.

Summer

The competitive play in the leagues continues until the middle of July. As described above this was the most successful year in the Club's history.

Interclub tournaments are played on an American tournament basis to encourage play.

The coaching for both juniors and seniors continues as well as tennis camps for juniors in all the school holidays

The social side of the club is very well supported with organised monthly tournaments in the summer months popular with the senior players in addition we celebrated our 50th anniversary with a large ball to celebrate the Club's 50 years. This raised some £9,000 to support the Club's activities.

Autumn

Finals Day in September closes the club tournament and summer playing programme.

Junior and senior coaching continues.

Competitive play continues under floodlights.

Winter

Junior coaching moves to an indoor venue.

For the hardy, the senior programme continues outdoors and during the evening play is under floodlights.
