In both of the above instances the prior year comparative has been restated so as to be consistent. The total value of Incoming resources and Resources expended remains unchanged as a consequence of the above reallocation in both the current and prior year.

The above reallocation of income and expenditure items is not considered to be a change in accounting policy and has been undertaken merely to allocate income and expenditure more properly.
