Summary of the purposes of the charity as set out in its governing document	Para 1.17	<p>The Object of the Royal Air Force Honington Officers' Mess is:</p> <p>'The promotion of efficiency of the Armed Forces of the Crown by the provision and support of facilities and activities for the efficiency and well-being of Service Personnel.'</p> <p>The object presents the Trustee with wide powers, enabling them to provide charitable assistance to all elements of the Royal Air Force Community; internal subsidy of mess activities and grant-making are the Royal Air Force Honington Officers' Mess' principal means of delivering charitable assistance.</p> <p>The Royal Air Force Honington Officers' Mess has three main aims set by the Trustee:</p> <ol style="list-style-type: none">Encourage esprit de corps by enabling serving Mess Members to mix together in both formal dining situations and informal social activities so as to help keep service traditions alive and encourage the well-being of the Mess community.Encourage, supporting and facilitating the development of sport to raise standards and to promote the link to fitness, teamwork and personal development through sporting activity and opportunities.Supporting facilities and capital projects to enable the possible provision for the Royal Air Force Honington community.

Para 1.17 and 1.19	The Officers' Mess derives public benefit as it assists in providing Royal Air Force personnel with the necessary skills to carry out the Royal Air Force contribution to defence of the United Kingdom and its interests. Service Funds are established for the benefit of Service personnel to promote military efficiency which underpins esprit de corps and team working, and they help to encourage personnel to develop the character, spirit and attitude to face challenges and danger associated with military service. As a result the Officers' Mess derives a benefit to the general public in helping to provide personnel who are motivated, have a high morale and are willing to serve the needs of their country and that of its public, at all times.

Policy on grant making	Para 1.38	Prior to the end of the Financial Year the Financial Plan/Budget is proposed to the Membership at an Extraordinary General Meeting (EGM). The plan details the proposed budget for the new Financial Year including grants, subsidies and any capital expenditure for ratification by the membership. If agreed at the EGM, minutes are then distributed to the Trustee for ratification and approval. The Mess Committee meetings take place each month to discuss finances and any other business of the Mess.
Policy on social investment including program related investment	Para 1.38	In line with RAF Honington Investments Reserve. The Investment Reserve contains monies that are invested to provide future security for The Mess. This fund remains within the CCLA and Schroders and will also provide additional income. The current investments are detailed within the FP. It should be noted that the total value of investments increased, however as a result of COVID-19, and the war in Ukraine the markets remain unpredictable.

Contribution made by volunteers	Para 1.38	Mess Funds fall into two categories: Unrestricted Funds and Restricted Funds Unrestricted funds are shown on Mess Bills as 'Mess Subscription', and are an amalgamation of the old charges that covered Maintenance, Entertainments, Mess Improvements & Beverages etc. Unrestricted Funds can be used to cover any of the areas mentioned above at the discretion of the Mess, without recourse to a General Meeting. Restricted Funds can only be used for the purpose for which they are collected, e.g. Sports Levy can only be passed to the Stn Sports Fund.
Other		The Mess committee meets on a monthly basis to decide on the support given to requests for assistance. Requests for assistance for activities are discussed by the committee and approved based on merits of the individual bids. Activities requesting assistance are asked to provide financial details of any fund held by them.

		The previous year saw a reduction in mess subscription to avoid generating too much cash. This subscription has been increased, albeit not to pre COVID-19 levels to ensure the increase in entertainments and projects are correctly managed, stopping the mess overspending.
Performance of fundraising activities against objectives set	Para 1.41	<p>The mess generates income by levying subscriptions and profits generated from the bar.</p> <p>Subscriptions: At the start of FY22/23 it was agreed, at the AGM, by the membership, in the financial plan that daily charges would be as follows; Livers in 0.62p per day Livers out 0.56p per day With the cancellation of all functions, events and reduced services the mess generated an underspend of £34,247.01 to carry forward into FY22/23.</p> <p>Bar Profits: Despite COVID-19 restrictions in place for 2 months, the bar generated more income than was expected that was expected at the start of the year. Bar profits of £9,081.85 were recorded against a predicted target of £6,640.00 resulting in a £2,441.85 profit in expected income.</p>

Further money was generated by subscription and investments giving a total income for the year of £75,343.85.</p> <p>From the financial plan there was planned expenditure of £73,508.00. Actual expenditure for the FY was £48,874.43. This left an underspend of £34,247.01 to carry forward to FY22/23. This is planned to be spent on further mess improvements and partially fund events due to the lack of them in the past year.</p> <p>The position of the charity is strong due to the continued effects of COVID-19 and the</p>

This sees the charity moving into the next financial year (FY22-23) with an underspend from the previous financial year and funds set aside in reserve.</p> <p>Liquidity At the end of the FY liquidity of the mess is excellent with net funds readily available of £84,032.29.</p> <p>Reserves The RAF Honington Officers' Mess holds a reserve of £15,000.00 in the current account.</p> <p>Investments The RAF Honington Officers' Mess has a number of investments to help secure funds to benefit the financial viability of the mess.</p> <p>Permanent Endowment The RAF Honington Officers' Mess was granted, from the RAF Central Fund, £17,150. This was to be used to for investment and to help better secure the mess financial future. This money is a liability to the mess and if the Mess were to close the money would be returned to the Central Fund.</p> <p>Schroders The majority of the investments held by RAF Honington Officers' Mess are held in the Schroders account. This includes the Permanent Endowment. At the end of the FY this was at £31,975.73.</p> <p>CCLA RAF Honington Officers' Mess also keep funds set aside for use at the discretion of the Trustee for an audit if they feel it is necessary. This is held in a low interest investment and this account had £3,288.60 at the end of this FY.</p> <p>Dividends Investments generated from a dividend pay-out are still to be confirmed.</p>
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	<p>AP3223, Leaflet 311, Operating Reserves Policy is the AIR policy that defines how and why reserves are held. This is formed from the higher-level government policy from CHARITIES SORP and CHARITIES SORP (FRSSE).</p> <p>The mess currently holds a reserve as directed by the Trustee. It was designed to ensure the charity had financial viability to meet payments for the mess for up to 3 months of no income to prevent the mess from going into the debt.</p>

He is satisfied that systems and procedures have been established in order to manage these risks. This is done through the means of a Service Funds Internal Audit Board, convened at the start of each Financial Year, to carry out internal arithmetical and management audit of the charity. In addition, the Trustee maintains a Risk Register detailing areas which may be cause of concern presently and into the future. Risks have been analysed and assessed according to their impact and likelihood of occurrence. Systems implemented to mitigate these risks are continually reviewed. The main risk over the year is as follows:</p> <p>Potential Risk Coast of living crisis will have an impact on the Messes as planned expenditure does not account for increased costings.</p> <p>Mitigation The Membership were made aware of potential increased costings. 
