1.1 Basis of preparation of accounts

The accounts are prepared under the historical cost convention and include the results of the charity's operations which are described in the Trustees' Report and all of which are continuing.

Public benefits, development, activities and achievements in the year

When planning our activities in the year, the trustees considered the Charities Commission's guidance on public benefit, and in particular the specific guidance on charities for the advancement of religion. We helped ordinary people in the community to live out their faith through worship and prayer; learning about the Gospel; and developing their knowledge and trust in Jesus Christ.

Transition to Online Services

In March 2020 we (the leadership team) decided to move our physical services online for the health and safety of our congregation, and for visitors who attend our worship services. The transition from physical to online was a smooth process for us, as prior to COVID-19 we were using Zoom twice a week to hold our Wednesday prayer service and Friday Bible study. Therefore, the pandemic only had a direct impact on our Sunday worship service (which is an integral part of what we do).

Congregation Welfare

The welfare of our congregation is very important to us. The pandemic changed the way that we interact with our church members, and ultimately took away our ability to have face-to-face counselling and fellowship sessions. GWCI has a church WhatsApp group which was set up in 2016, this platform has been used to communicate with the congregation throughout the pandemic. We also sent messages to congregation members individually to check on them, and to remind them that the Senior Pastor is available for counselling and prayer sessions virtually.

Leadership Team Meetings

Throughout the pandemic and to date the leadership team have continued to meet to discuss matters concerning the church. These meetings have been held virtually, and notes and minutes for each meeting are taken and kept for records.

Future Developments

Currently our services and activities are still being held virtually due to a change in provision with the space we hired pre-COVID-19, and we are currently exploring other venue options that meets our needs as a church. Physical meetings are very important to us, and over the pandemic we have had new individuals join our church zoom meetings that we have never physically met. Therefore as the government relaxed COVID-19 restrictions we have planned different recreational activities that will allow our congregation to come together in-line with government guidelines.
