Mainly in the Scottish Borders to home sighthounds and we have also helped place other breeds of dogs with them when members of the public have contacted us for help.</p> <p>We have maintained a strict policy of never euthanising a healthy dog by accommodating dogs that would be difficult to rehome within the Greyhound Rescue North East team, in foster placements or permanent residence at our kennels.</p> <p>We have permanently accommodated any dog that are not suitable for rehoming.</p>

His contribution is fundamental to the care of the dogs and the day-to-day running of the charity.
