EXTRACT FROM CLAUSE 5 (VII) OF THE TRUST DEED DATED 27 JULY 2006. OBJECT 3 TO DEVELOP TECHNIQUES FOR MAINTENANCE AND PRESERVATION OF THE STRUCTURE OF THE WALLS AND TO TRAIN PEOPLE IN THE SKILLS REQUIRED TO CARRY OUT THESE TECHNIQUES. EXTRACT FROM CLAUSE 5 (VIII) OF THE TRUST DEED DATED 27 JULY 2006.
