

15th ANNUAL MEETING OF THE TRUSTEES

Hugh Marsden took the chair to welcome the Trustees to the 15th Annual Meeting of The Peguera Trust for the year to 31 December 2022 – thus opening the meeting on Monday 11th September to David Wadham – Katy Lindfield Butler and Rebecca Williams all of whom were remotely connected for the occasion.

1. Hugh Marsden thanked the Trustees and the Independent Examiner for their contribution in running the Trust. He confirmed once again that the purpose of the Trust is to grow the Funds over time, and to make payments to a range of charitable causes, primarily but not exclusively from income. The Total value of the Fund at the year end was £221,088
2. Hugh Marsden wanted to thank David Wadham FRCS who prepared the accounts and Bertie Maxwell who acted as our Independent Examiner to confirm that the accounts were suitably presented.
3. Hugh Marsden proposed, and it was agreed, that Edward Thornton, as a Divisional Director of RBC Brewin Dolphin, would again review the investment strategy and the portfolio, conferring with him from time to time. Hugh Marsden wanted it noted once again that, as the source of the funds, he wished the Portfolio to be reasonably balanced for growth with an income strategy without any formal allocation of funds, in particular no allocation to fixed interest stocks.
4. It was proposed and agreed that the trustees communicate by telephone, email as necessary and at least annually in person or the equivalent on-line.
5. Hugh Marsden confirmed that all donations were to registered charities, or in a few cases to organisations serving a good and charitable cause and to a range of worthy good causes. The list of donations for the year, totalling £22,425 was duly circulated by email
6. The income of the Trust in 2022 exceeded the threshold and an Independent examiner's Report was thus required, and duly registered on the CC Annual Return
7. Hugh Marsden confirms that once again he will make a timely report as required by The Charity Commission.
8. No other business was proposed and it was agreed that the next meeting would be held similarly in due time next year. Any matters arising in the meantime would be communicated as indicated above.
