2. Structure, Governance and Management

Legal Structure

The Kerbascol Trust is a charitable trust registered with the Charity Commission of England and Wales. It operates under a Trust Deed which sets out its objectives and the powers of the Trustees.

Trustee Recruitment and Induction

Trustees are appointed by the existing Trustees in accordance with the Trust Deed. New Trustees are provided with an overview of the Trust's objectives, activities, and financial position on appointment. During the year, the Trustees identified two potential new Trustees and took steps to introduce them to the existing board with a view to formal appointment in the next period.

Trustee Changes

Michael Pragnell resigned as a Trustee at the meeting held on 23 July 2024. The Trustees formally noted his resignation and his long-standing contribution to the Trust with gratitude. The Trust continued to be properly constituted following his resignation.

Meetings

The Trustees held two formal meetings during the year:

- Wednesday, 13 December 2023 – held via Zoom
- Tuesday, 23 July 2024 – held via Zoom

At both meetings, full consideration was given to the Trust's financial position, investment performance, charitable grants, and governance matters. Minutes were circulated to all Trustees following each meeting.

3. Objectives and Activities

The Kerbascol Trust exists to support charitable causes with a particular focus on organisations working with young people and those in need. The Trust's approach is to make direct grants to registered charities whose work demonstrably benefits the communities and individuals they serve. In selecting beneficiaries, the Trustees consider the size and capacity of organisations, seeking to ensure that the Trust's contributions make a meaningful and measurable difference.

The Trustees have due regard to the Charity Commission's guidance on public benefit and are satisfied that the Trust's activities meet the public benefit requirement.

4. Achievements and Performance

Grants Made During the Year

During the year ended 30 September 2024, the Trustees approved and made the following charitable grants:

Grants Arising from the December 2023 Meeting

At the meeting of 13 December 2023, the Trustees reviewed a number of funding applications and agreed donations to several charities. These donations were paid in early February 2024. The beneficiary organisations considered included:

- Hestia

- Animal Antiks
- Go Beyond

Be Free Young Carers – New Grant (September 2024)

A significant grant of £10,000 was approved and paid to Be Free Young Carers (BFYC) in September 2024. BFYC is a small Oxfordshire-based charity that provides social and emotional support to young carers – individuals under the age of 25 who care for an adult family member or friend.

The Chairman first met with BFYC at the beginning of 2024 and presented the charity to the full board in May 2024. Following approval at the July 2024 meeting, the donation was designated specifically to support BFYC's Emotional Support programme. BFYC reported that a donation of £10,000 would enable them to support approximately 45 young carers across South Oxfordshire, Oxford City and the Vale of White Horse through their six-week emotional support programme, which combines counselling sessions, mindfulness skills, and wellbeing activities.

The Trustees were particularly attracted to BFYC's ambition to expand from their existing partnerships with primary schools in south Oxfordshire into Oxford City, and felt that the Trust's support could help catalyse this growth. The Trustees expressed a desire to develop this into a longer-term relationship, subject to satisfactory ongoing review.

July 2024 Meeting – Further Grant Considerations

At the meeting of 23 July 2024, the Trustees also considered new funding requests from Animal Antiks and Go Beyond. The outcome of these deliberations is reflected in the financial statements.

5. Financial Review

Overview

The financial statements for the year ended 30 September 2024 have been independently examined by Karen Whiley. The Trustees are satisfied that the financial records have been properly maintained and that the accounts present a true and fair view of the Trust's financial position.

Investment Performance

The Trust's investment portfolio is managed by James Weaver at Goldman Sachs Private Wealth Management and is held in the Goldman Sachs Balanced Asset Portfolio (BAP). James Weaver provides regular reports to the Trustees.

As at the end of Q2 2024 (30 June 2024), the portfolio delivered a return of +4.89% year to date, outperforming the ARC Sterling Balanced Index by 67 basis points. As at 19 July 2024, the portfolio was up +5.60% year to date, equivalent to annualised returns of +8.32% since inception. The Trustees are pleased with this performance and are satisfied that the

investment approach continues to provide a sound basis for the Trust's grant-making activities.

During the year, the portfolio was rebalanced with a disposal of real estate and infrastructure trackers, the proceeds of which were reinvested into the core equity allocation of the fund. This decision was made in line with market consensus views on the outlook for those sectors.

Banking Arrangements

The Trust maintains accounts with CAF Bank. During September 2024, the Trustees opened a new CAF 60 Day Notice Account with Shawbrook Bank to provide a better return on cash holdings. An initial deposit of £20,000 was transferred to this account.

Reserves Policy

The Trustees maintain sufficient reserves to enable the Trust to meet its ongoing commitments to beneficiaries and to cover operational costs. The Trust's policy is to hold reserves at a level that supports the planned programme of grant-making. The level of reserves is reviewed at each Trustee meeting.

Going Concern

The Trustees are satisfied that the Trust has adequate resources to continue its charitable activities for the foreseeable future and that it is appropriate to prepare the accounts on a going concern basis.

6. Plans for Future Periods

Looking ahead, the Trustees intend to:

- Continue to develop the Trust's relationship with Be Free Young Carers and keep its impact under review, with a view to making further grants in support of its growth.
 - Formally recruit two new Trustees who were identified during the year and introduced to the board, in order to strengthen the governance of the Trust.
 - Continue to review applications from existing and new beneficiary organisations at the next scheduled Trustees' meeting.
 - Keep the Trust's investment strategy under review in consultation with Goldman Sachs, to ensure it continues to support the Trust's long-term grant-making objectives.

- State whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements;
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the Trust Deed. They are also responsible for safeguarding the assets of the charity and hence taking reasonable steps for the prevention and detection of fraud and other irregularities.
