RECENT FUND RAISING HAS INCLUDED MUSICAL EVENTS, TALKS, A LECTURE OF LOCAL HISTORICAL / HERITAGE INTEREST, AN ART EXHIBITION AND A WW1 ARMISTICE CENTENARY EXHIBITION WHICH ATTRACTED DONATIONS.
