## **Annual Report for 2024**

The Charity Trustees present their Annual Report and financial statements for the year ended 31 December 2024.

### **Charitable Purpose**

The Charity is governed by an Approved Governing Document which states that the principal purpose of the Charity is the advancement of the Christian faith according to the principles of the Baptist denomination. The Church may also within the principal purpose advance education and carry out other charitable purposes in the United Kingdom and/or other parts of the world.

The Church occupies premises which are held by The Baptist Union Corporation Limited as Holding Trustees on behalf of the Church in compatibility with the Charitable Purpose.

The Church is a member of the Baptist Union of Great Britain, the Commission association of churches and the Evangelical Alliance.

### **Organisational Structure and Decision-Making Processes**

Formal Church Members' Meetings take place at least three times a year which have responsibility for the overall policy of the Church. In accordance with the Approved Governing Document, the members appoint the Minister, the Elders, the Church Secretary, the Treasurer and the Charity Trustees who have responsibility for the day to day running of the Church's work and witness and the financial and legal aspects of the Charity. All members are encouraged to take an appropriate part in the spiritual and practical tasks involved in the furtherance of the Charitable Purpose.

Relevant matters may be submitted to the Church Members' Meeting by the Elders or Charity Trustees for guidance or may be raised by members at the Church Members' Meeting for further consideration by the Charity Trustees. Although the Approved Governing Document permits decisions to be made at the Church Members' Meetings by appropriate majorities, the Church seeks to work by consensus wherever possible.

Baptism by immersion upon personal profession of faith is expected of all persons prior to reception into membership of the Church. However, persons seeking membership who have not been baptised in this manner may, at the discretion of the Charity Trustees, be received into membership based on their own public profession of faith (subject to acceptance by the Church Members' Meeting).

### **Objectives and Activities**

In order to fulfil the Charitable Purpose set out above, the Church provides a number of activities both for its membership and for the community generally. The aim is to show the love of Jesus

Christ in both word and deed and to bring people into a closer relationship with Him as living Lord.

The pastoral team continues to oversee the care of the congregation to try to ensure that people feel supported emotionally, spiritually and practically as necessary.

Central to the work and witness of the Church is the provision of regular public services of Christian worship, Bible teaching and prayer. The main Sunday service is at 10.00am where the focus is on worship and Bible teaching. A children's programme is provided at the same time as the morning service. Other services are arranged from time to time as appropriate. Groups meet for prayer normally on Saturday mornings and Sunday evenings. The Church seeks to be a friendly and welcoming community and anybody is free to attend any of these services or meetings.

During the week, life groups meet generally in members' houses with a view to pastoral support, encouraging one another in faith and in working out the practical implications of being a Christian and living in the general community. All regular Church attendees are encouraged to belong to one these life groups.

Other weekly activities include "Hope Toddlers" (formerly called "Little Feet") on Monday mornings (a mother and toddler group), "Options" on Tuesday mornings (mainly for women of all ages), and "Hope Kids and Coffee" (formerly called "Engage") on Friday afternoons (for primary school children and their parents/carers). These meetings are all open to the general public.

Further activities/courses take place as the need arises. These have included "Alpha" (for those wishing to find out more about the Christian faith), "Freedom in Christ" (understanding who we are as Christians), men's and women's breakfasts/dinners, mentoring children at risk of exclusion (supporting Transforming Lives for Good, a children's charity) and youth weekends. Contacts are maintained with local schools in particular through taking assemblies and classes from time to time.

A major objective is to reach out to the community in social action to show God's generous heart through benefit to the public. To this end, free activities have been organised from time to time such as quizzes, musical evenings, community fun days and pantomimes. We have continued to work with St Thomas' church in Holtspur and One Can Trust, a food bank based in High Wycombe to deliver food parcels to the local community. The church continues to collect items for the food bank both from within the congregation and from local supermarkets.

The Church has a comprehensive Safeguarding Policy with procedures to ensure that people working with children and vulnerable adults are appropriately managed and vetted with regard to the government's Disclosure and Barring Service.

The Church does not believe its ministry stops at Beaconsfield and support for other activities is given by providing grants to a range of charitable organisations, both in the UK and overseas, that are involved in furthering the Christian message and social action by providing practical help to those in need. There is participation by the Church in the national programme of filling and sending Christmas Boxes to children in deprived areas overseas.

The Charity Trustees have noted the Charity Commission guidance on public benefit and are satisfied that the activities outlined above clearly demonstrate that the Charity is providing a benefit to the public.

### **Achievements and Performance**

The Church does not measure the success of its programmes only in numbers, including financial numbers, but also in less tangible areas like fellowship, encouragement, spiritual growth and generally providing a positive, beneficial impact in the community. The Charity Trustees recognise that these are not easy to measure but believe that 2024 was a positive year in the life of the Church and that it is well placed to continue pursuing its Charitable Purpose in 2025 and beyond.

Church membership stands at 50. Normal attendance at services is in excess of this number with larger numbers from time to time on special occasions. There are a good number of children who attend church activities over the week.

There are good attendances by members and the general public at most activities. The community events and activities are popular and some very positive feedback has been received from the council, the public and local newspapers.

### **Financial Review**

The financial results for the year together with a summary of the accounting policies adopted are set out in the accompanying financial statements.

The Church had income of £323,969 and expenditure of £246,501 resulting in a surplus of £77,468. Income was supported by a generous legacy of £115,000. The Church continues to update and modernise the premises, incurring capital expenditure on the church building of £24,860 in 2024 with further expenditure planned in 2025.

The year ended in a healthy financial position with £262,606 in free cash. A further £118,013 was on deposit with The Baptist Union Corporation Limited, the use of which funds was initially restricted to buildings projects but which the Baptist Union Trustees have indicated may now be used for more broadly based expenditure (refer note 2). The Church raises the funds which it needs to carry on its activities from within its own membership and congregation. No wider public appeal for funds was made during the year.


Staff costs are set out in note 10. Some administrative support is provided by volunteers.

Grants were made to national and international organisations with Christian aims and objectives compatible with the Church's Charitable Purpose. The main details of such grants are set out in note 8.

The Church is heavily dependent on its membership working as volunteers in all aspects of the Church's activities, many of which run with little or no impact on the Church's expenditure, but which nevertheless contribute substantially to the achievement of the Church's Charitable Purpose.

The Charity Trustees have established a Reserves Policy and are satisfied that there are sufficient reserves at the balance sheet date, together with ongoing income anticipated, to enable the Church to function effectively in the coming year.

The Charity Trustees have made an assessment of major risks facing the Church and are satisfied that there are measures in place to minimise these risks.

(a) Basis of preparation

The accounts are prepared in accordance with the Accounting regulations set out under the Charities Act 2011.

(b) Gifts and donations

Gifts, donations and tax rebates are accounted for when received.

(c) Legacies

(d) Grants payable

The Church makes grants to other organisations whose charitable objects complement its work. They are accounted for in the year in which they are paid.

(e) Governance costs

This represents direct expenditure on the governance of the church. Most of the management is carried out without charge by volunteers. Consequently there is little direct expenditure on governance.

**2. Reserves**

Funds in the unrestricted income fund can be applied against any expenditure.

The Capital Fund represents funds allocated by the trustees, to be used for strategic purposes or property transactions. All these funds are deposited with the Baptist Union. Funds can be accessed upon approval in a church meeting and with the consent of the Baptist Union Corporation trustees. The Fund was initially restricted to property related matters but given the church's ownership of a church building and a manse, the Baptist Union Trustees have indicated they would give consent to more broadly based expenditure.

pandemic and still remains at a much higher level than before. The church continues to collect items for the food bank both from within the congregation and from local supermarkets.

There is participation by the Church in the national programme of filling and sending Christmas Boxes to children in deprived areas overseas.

The Charity Trustees have noted the Charity Commission guidance on public benefit and are satisfied that the activities outlined above clearly demonstrate that the Charity is providing a benefit to the public.

### **Achievements and Performance**

The Church does not measure the success of its programmes only in numbers, including financial numbers, but also in less tangible areas like fellowship, encouragement, spiritual growth and generally providing a positive, beneficial impact in the community. The Charity Trustees recognise that these are not easy to measure but believe that 2023 was a positive year in the life of the Church and that it is well placed to continue pursuing its Charitable Purpose in 2024 and beyond.

## Financial Review

The Church had income of £202,194 and expenditure of £216,010 resulting in a deficit of £13,816.

The year ended in a healthy financial position with £187,767 in free cash. ## **Annual Report for 2022**

The Charity Trustees present their Annual Report and financial statements for the year ended 31 December 2022.

### **Charitable Purpose**

The Charity is governed by an Approved Governing Document which states that the principal purpose of the Charity is the advancement of the Christian faith according to the principles of the Baptist denomination. The Church may also within the principal purpose advance education and carry out other charitable purposes in the United Kingdom and/or other parts of the world.

The Church occupies premises which are held by The Baptist Union Corporation Limited as Holding Trustees on behalf of the Church in compatibility with the Charitable Purpose.

The Church is a member of the Baptist Union of Great Britain, the Commission association of churches and the Evangelical Alliance.

### **Staffing Changes**

As reported in the 2021 Annual Report, Matt Jones, a full-time Elder of the Church was appointed Pastor on 16 January 2022. Matt was also invited to move into the Church manse, which he did in February 2022.

The Church also agreed to appoint a part-time Administrative Facilitator who took up the post on 1 January 2023.

The Church benefitted from having two interns during the year. Morgan Jones and Alice Early took on these roles in September 2021 for one year. At the end of this period, Morgan left, as planned, but Alice's role was extended for a second year.

The beginning of the year continued to be affected by the Covid 19 pandemic but meetings were largely back to normal by the Spring. Sunday services continued to also be transmitted via YouTube to assist those who felt unable to attend because of health concerns. The pastoral team continues to oversee the care of the congregation to try to ensure that people feel supported emotionally, spiritually and practically as necessary.

Central to the work and witness of the Church is the provision of regular public services of Christian worship, Bible teaching and prayer. 

## **Annual Report for 2021**

The Charity Trustees present their Annual Report and financial statements for the year ended 31 December 2021.

### **Charitable Purpose**

The Charity is governed by an Approved Governing Document which states that the principal purpose of the Charity is the advancement of the Christian faith according to the principles of the Baptist denomination. The Church may also within the principal purpose advance education and carry out other charitable purposes in the United Kingdom and/or other parts of the world.

The Church occupies premises which are held by The Baptist Union Corporation Limited as Holding Trustees on behalf of the Church in compatibility with the Charitable Purpose.

The Church is a member of the Baptist Union of Great Britain, the Commission association of churches and the Evangelical Alliance.

### **Staffing and Eldership Changes**

Matt Jones, who had been working part-time in the Church since September 2019, was appointed as an Elder on 6 June 2021. Tom Williams, Minister, Lead Elder and Trustee, left in August 2021 to take up a new role at Mosaic Church, Basingstoke, another church in the Commission family of churches. The Elders felt it right not to appoint a Lead Elder when Tom left but to lead the Church as a team. Matt became full-time on 1 August 2021 and was subsequently appointed Pastor on 16 January 2022. Matt was also invited to move into the Church manse, which he did in February 2022.

The Church has also benefitted from having two interns during the year. Morgan Jones and Alice Early took on these roles in September 2021 for one year.

### **Organisational Structure and Decision Making Processes**

Formal Church Members' Meetings take place at least three times a year which have responsibility for the overall policy of the Church. In accordance with the Approved Governing Document, the members appoint the Minister, the Elders, the Church Secretary and the Treasurer. All of these roles include appointment as Charity Trustees having responsibility for the day to day running of the Church's work and witness and the financial and legal aspects of the Charity. All members are encouraged to take an appropriate part in the spiritual and practical tasks involved in the furtherance of the Charitable Purpose.

Relevant matters may be submitted to the Church Members' Meeting by the Charity Trustees for guidance or may be raised by members at the Church Members' Meeting for further consideration by the Charity Trustees. Although the Approved Governing Document permits decisions to be made at the Church Members' Meetings by appropriate majorities, the Church seeks to work by consensus wherever possible.

Baptism by immersion upon personal profession of faith is expected of all persons prior to reception into membership of the Church. However, persons seeking membership who have not been baptised in this manner may, at the discretion of the Charity Trustees, be received into membership based on their own public profession of faith (subject to acceptance by the Church Members' Meeting).

### **Objectives and Activities**

In order to fulfil the Charitable Purpose set out above, the Church provides a number of activities both for its membership and for the community generally. The aim is to show the love of Jesus Christ in both word and deed and to bring people into a closer relationship with Him as living Lord.

The year continued to be affected by the Covid 19 pandemic. The church was careful to comply with regulations and guidelines issued by the government and updated its Covid 19 risk assessment from time to time as regulations and guidelines changed. Regular activities are described below as they happen in normal times but many could not take place in the normal way. Services continued to be held but transmitted via YouTube. When permitted, people were allowed to attend in accordance with regulations and guidelines. A children's programme was also created and transmitted via YouTube. Other activities, such as life groups, prayer meetings, social activities and other meetings (including formal church meetings) took place via Zoom as necessary. The pastoral team took extra care to try to ensure that people felt supported emotionally, spiritually and practically as necessary. Normal meetings were fully resumed by the summer although services have continued to be streamed via YouTube for the benefit of those who felt unable to attend normal services.

Central to the work and witness of the Church is the provision of regular public services of Christian worship, Bible teaching and prayer. The main Sunday service is at 10.00am where the focus is on worship and Bible teaching. A children's programme is provided at the same time as the morning service. Other services are arranged from time to time as appropriate. Groups meet for prayer normally on Saturday mornings and Sunday evenings. The Church seeks to be a friendly and welcoming community and anybody is free to attend any of these services or meetings.

During the week, life groups meet generally in members' houses with a view to pastoral support, encouraging one another in faith and in working out the practical implications of being a Christian and living in the general community. All regular Church attendees are encouraged to belong to one these life groups .

Other weekly activities include "Hope Toddlers" (formerly called "Little Feet") on Monday mornings (a mother and toddler group), "Options" on Tuesday mornings (mainly for women of all ages), and "Hope Kids and Coffee" (formerly called "Engage") on Friday afternoons (for primary school children and their parents/carers). These meetings are all open to the general public. These activities were largely suspended during the Covid 19 pandemic.

Further activities/courses take place regularly or as needed such as “Christianity Explored” or “Alpha” (for those wishing to find out more about the Christian faith), “Digging for Gold” (in-depth Bible studies), “Discovery” (exploring what you are good at), “Freedom in Christ” (understanding who we are as Christians), men’s and women’s breakfasts/dinners, youth weekends, parenting courses, marriage courses and money management courses (linked with “Christians Against Poverty” debt management charity). Contacts are maintained with local schools in particular through taking assemblies and classes from time to time.

A major objective is to reach out to the community in social action to show God’s generous heart through benefit to the public. To this end, free activities have been organised from time to time such as quizzes, musical evenings, community fun days and pantomimes. We have continued to work with St Thomas’ church in Holtspur and One Can Trust, a food bank based in High Wycombe to deliver food parcels to the local community. Demand sharply increased during the pandemic and still remains at a much higher level than before. The church continues to collect items for the food bank both from within the congregation and from local supermarkets. In 2016, a Job Club was started on Friday mornings in association with “Christians Against Poverty.” This is designed to provide friendly practical support to help jobseekers step confidently into employment. A Job Club that was running in March 2020 was suspended when Covid 19 rules were established. Since then, individual people have been helped over the telephone/email but no courses have taken place.

The Church operates systems to ensure that people working with children and vulnerable adults are appropriately vetted with regard to the government’s Disclosure and Barring Service.

The Church does not believe its ministry stops at Beaconsfield and support for other activities is given by providing grants to a range of charitable organisations, both in the UK and overseas, that are involved in furthering the Christian message and social action by providing practical help to those in need. There is participation by the Church in the national programme of filling and sending Christmas Boxes to children in deprived areas overseas.

The Charity Trustees have noted the Charity Commission guidance on public benefit and are satisfied that the activities outlined above clearly demonstrate that the Charity is providing a benefit to the public.

### **Achievements and Performance**

The Church does not measure the success of its programmes only in numbers, including financial numbers, but also in less tangible areas like fellowship, encouragement, spiritual growth and generally providing a positive, beneficial impact in the community. The Charity Trustees recognise that these are not easy to measure but believe that 2021 was a positive year in the life

of the Church and that it is well placed to continue pursuing its Charitable Purpose in 2022 and beyond.

Church membership stands at 65. Normal attendance at services is in excess of this number with larger numbers from time to time on special occasions. There are a good number of children who attend church activities over the week.

There are good attendances by members and the general public at most activities. The community events and activities are popular and some very positive feedback has been received from the council, the public and local newspapers.

### **Financial Review**

The financial results for the year together with a summary of the accounting policies adopted are set out in the accompanying financial statements.

The Church had income of £293,350 and expenditure of £168,658 resulting in a surplus of £124,692. The exceptionally large surplus was as a result of a legacy of £120,000 received during the year.

The year ended in a healthy financial position with £174,135 in free cash. A further £144,397 was on deposit with The Baptist Union Corporation Limited, the use of which funds was initially restricted to buildings projects but which the Baptist Union Trustees have indicated may now be used for more broadly based expenditure (refer note 2). The Church raises the funds which it needs to carry on its activities from within its own membership and congregation. No wider public appeal for funds was made during the year.

During the year, a full-time Minister and part-time Assistant Pastor were employed until August when the Minister left. From then, the Assistant Pastor became full-time and two paid interns were appointed for one year from September 2021. These costs are set out in note 9. Some administrative support is provided by volunteers.

Grants were made to national and international organisations with Christian aims and objectives compatible with the Church's Charitable Purpose. The main details of such grants are set out in note 7.

The Church is heavily dependent on its membership working as volunteers in all aspects of the Church's activities, many of which run with little or no impact on the Church's expenditure, but which nevertheless contribute substantially to the achievement of the Church's Charitable Purpose.

The Charity Trustees have established a Reserves Policy and are satisfied that there are sufficient reserves at the balance sheet date, together with ongoing income anticipated, to enable the Church to function effectively in the coming year.

The Charity Trustees have made an assessment of major risks facing the Church and are satisfied that there are measures in place to minimise these risks.

The Church occupies premises which are held by The Baptist Union Corporation Limited as Holding Trustees on behalf of the Church in compatibility with the Charitable Purpose.

The Church is a member of the Baptist Union of Great Britain, the Commission association of churches and the Evangelical Alliance.

### **Organisational Structure and Decision Making Processes**

Formal Church Members' Meetings take place at least three times a year which have responsibility for the overall policy of the Church. In accordance with the Approved Governing Document, the members appoint the Minister, the Elders, the Church Secretary and the Treasurer. All of these roles include appointment as Charity Trustees having responsibility for the day to day running of the Church's work and witness and the financial and legal aspects of the Charity. All members are encouraged to take an appropriate part in the spiritual and practical tasks involved in the furtherance of the Charitable Purpose.

Relevant matters may be submitted to the Church Members' Meeting by the Charity Trustees for guidance or may be raised by members at the Church Members' Meeting for further consideration by the Charity Trustees. Although the Approved Governing Document permits decisions to be made at the Church Members' Meetings by appropriate majorities, the Church seeks to work by consensus wherever possible.

Baptism by immersion upon personal profession of faith is expected of all persons prior to reception into membership of the Church. However, persons seeking membership who have not been baptised in this manner may, at the discretion of the Charity Trustees, be received into membership based on their own public profession of faith (subject to acceptance by the Church Members' Meeting).

### **Objectives and Activities**

In order to fulfil the Charitable Purpose set out above, the Church provides a number of activities both for its membership and for the community generally. The aim is to show the love of Jesus

Christ in both word and deed and to bring people into a closer relationship with Him as living Lord.

The year was significantly affected by the Covid 19 pandemic. The church was careful to comply with regulations and guidelines issued by the government and completed a full Covid 19 risk assessment which was updated from time to time as regulations and guidelines changed. Regular activities are described below as they happen in normal times but many could not take place in the normal way. Services continued to be held but transmitted via Youtube. When permitted, people were allowed to attend in accordance with regulations and guidelines. A children's programme was also created and transmitted via Youtube. Other activities, such as lifegroups, prayer meetings, social activities and other meetings (including formal church meetings) took place via Zoom. The pastoral team took extra care to try to ensure that people felt supported emotionally, spiritually and practically as necessary.

Central to the work and witness of the Church is the provision of regular public services of Christian worship, Bible teaching and prayer. The main Sunday service is at 10.00am where the focus is on worship and Bible teaching. A children's programme is provided at the same time as the morning service. Other services are arranged from time to time as appropriate. Groups meet for prayer normally on Thursday, Friday and Saturday mornings and Sunday evenings. The Church seeks to be a friendly and welcoming community and anybody is free to attend any of these services or meetings.

During the week, lifegroups meet generally in members' houses with a view to pastoral support, encouraging one another in faith and in working out the practical implications of being a Christian and living in the general community. Several activity-based groups were also established in order to help deepen relationships. The nature of these new groups will vary from time to time but initially included groups for craft, community involvement, dancing and running. All regular Church attendees are encouraged to belong to one or more of these lifegroups or activity groups.

Other weekly activities normally include "Little Feet" on Monday mornings (a mother and toddler group), "Options" on Tuesday mornings (for women of all ages), "Get Real" on Monday evenings for teenagers and "Engage" on Friday afternoons (for primary school children). These meetings are all open to the general public. These activities were largely suspended during the Covid 19 pandemic.

Further activities/courses take place regularly or as needed such as "Christianity Explored" or "Alpha" (for those wishing to find out more about the Christian faith), "Digging for Gold" (in-depth Bible studies), "Discovery" (exploring what you are good at), "Freedom in Christ" (understanding who we are as Christians), men's and women's breakfasts/dinners, youth weekends, parenting courses, marriage courses and money management courses (linked with "Christians Against Poverty" debt management charity). Contacts are maintained with local schools in particular through taking assemblies and classes from time to time.

A major objective is to reach out to the community in social action to show God's generous heart through benefit to the public. To this end, free activities are organised during the year. Activities

undertaken include quizzes, musical evenings and organising a community fun day on the green outside the town hall. In conjunction principally with St Thomas' church in Holtspur, we operate a food bank pick-up point run in association with One Can Trust, a food bank based in High Wycombe. As the pandemic took hold, the demand for food parcels sharply increased and St Thomas' maintained a food larder at their church in conjunction with a local communities organisation (Better Connected Beaconsfield) and One Can Trust. Arrangements were made to deliver food parcels rather than clients picking them up themselves. The church continues to collect items for the food bank both from within the congregation and from local supermarkets. In 2016, a Job Club was started on Friday mornings in association with "Christians Against Poverty." This is designed to provide friendly practical support to help jobseekers step confidently into employment. A Job Club that was running in March 2020 was suspended when Covid 19 rules were established. Since then, individual people have been helped over the telephone/email but no courses have taken place.

The Church operates systems to ensure that people working with children and vulnerable adults are appropriately vetted with regard to the governments's Disclosure and Barring Service.

The Church does not believe its ministry stops at Beaconsfield and support for other activities is given by providing grants to a range of charitable organisations, both in the UK and overseas, that are involved in furthering the Christian message and social action by providing practical help to those in need. There is participation by the Church in the national programme of filling and sending Christmas Boxes to children in deprived areas overseas.

The Charity Trustees have noted the Charity Commission guidance on public benefit and are satisfied that the activities outlined above clearly demonstrate that the Charity is providing a benefit to the public.

### **Achievements and Performance**

The Church does not measure the success of its programmes only in numbers, including financial numbers, but also in less tangible areas like fellowship, encouragement, spiritual growth and generally providing a positive, beneficial impact in the community. The Charity Trustees recognise that these are not easy to measure but believe that 2020 was a positive year in the life of the Church and that it is well placed to continue pursuing its Charitable Purpose in 2020 and beyond.

Church membership stands at 80. Normal attendance at services is in excess of this number with larger numbers from time to time on special occasions. There are a good number of children who attend church activities.

There are good attendances by members and the general public at most activities. The community events and activities are popular and some very positive feedback has been received from the council, the public and local newspapers.

### **Financial Review**

The financial results for the year together with a summary of the accounting policies adopted are set out in the accompanying financial statements.

The Church had income of £183,300 and expenditure of £193,427 resulting in a deficit of £10,127.

The year ended in a healthy financial position with £49,742 in free cash. A further £144,098 was on deposit with The Baptist Union Corporation Limited, the use of which funds was initially restricted to buildings projects but which the Baptist Union Trustees have indicated may now be used for more broadly based expenditure (refer note 2). The Church raises the funds which it needs to carry on its activities from within its own membership and congregation. No wider public appeal for funds was made during the year.

A senior Minister is employed full-time and an Assistant Pastor was employed part-time. These costs are set out in note 9. Some administrative support is provided by volunteers.

Grants were made to national and international organisations with Christian aims and objectives compatible with the Church's Charitable Purpose. The main details of such grants are set out in note 7.

The Church is heavily dependent on its membership working as volunteers in all aspects of the Church's activities, many of which run with little or no impact on the Church's expenditure, but which nevertheless contribute substantially to the achievement of the Church's Charitable Purpose.

The Charity Trustees have established a Reserves Policy and are satisfied that there are sufficient reserves at the balance sheet date, together with ongoing income anticipated, to enable the Church to function effectively in the coming year.

The Charity Trustees have made an assessment of major risks facing the Church and are satisfied that there are measures in place to minimise these risks.

**1. Accounting policies**

(a) Basis of preparation

The accounts are prepared in accordance with the Accounting regulations set out under the Charities Act 2011.

(b) Gifts and donations

Gifts, donations and tax rebates are accounted for when received.

(c) Legacies

Legacies are accounted for when received

(d) Grants payable

The Church makes grants to other organisations whose charitable objects complement its work. They are accounted for in the year in which they are paid.

(e) Governance costs

This represents direct expenditure on the governance of the church. Most of the management is carried out without charge by volunteers. Consequently there is little direct expenditure on governance.

**2. Reserves**

Funds in the unrestricted income fund can be applied against any expenditure.

The Capital Fund represents funds allocated by the trustees, to be used for strategic purposes or property transactions. All these funds are deposited with the Baptist Union. Funds can be accessed upon approval in a church meeting and with the consent of the Baptist Union Corporation trustees. The Fund was initially restricted to property related matters but given the church's ownership of a church building and a manse, the Baptist Union Trustees have indicated they would give consent to more broadly based expenditure.
