## MAJOR ACTIVITIES AND ACHIEVEMENTS IN THE YEAR

### The purpose of Scouting

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

### The values of Scouting

As Scouts we are guided by these values:

**Integrity** - We act with integrity; we are honest, trustworthy and loyal.

**Respect** - We have self-respect and respect for others.

**Care** - We support others and take care of the world in which we live.

**Belief** - We explore our faiths, beliefs and attitudes.

**Co-operation** - We make a positive difference; we co-operate with others and make friends.

### The Scout Method

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- enjoy what they are doing and have fun
- take part in activities indoors and outdoors
- learn by doing
- share in spiritual reflection
- take responsibility and make choices
- undertake new and challenging activities
- make and live by their Promise.

The Group comprises 55 youth members covering the Beaver Scouts, Cub Scouts and Scout sections. In addition, 28 adults were involved as leaders or administrators - all of whom gave their services voluntarily.

While the national lockdown measures associated with the COVID-19 pandemic were easing through the period of this report, adverse impacts on the range of activities and Group costs continued. The Group maintained face to face scouting throughout the year using appropriate precautions based on national guidance. An activity day took place at Southall Activity Centre in October 2021 attended by all sections in the Group. Planning took place for the June 2022 Group Camp to be run alongside the District Camp. The Group held a Christmas 2021 food bank collection in support of the important work by Ealing Food Bank.

No fundraising events were held during the year. The Group did receive Business Support Grants as detailed in the finance report. Subscriptions from the youth members to assist with utilities, operational, premises and annual capitation costs continued through the year.

Commencing in Autumn of 2021 the Group started a programme to seek additional adult support for the Scout section and across the Group. This filled a number of key roles within the Group. Towards the close of the period of this report in March 2022 the Scout section was having difficulties in maintaining adult support to continue with the numbers and meeting arrangements.

The Group's governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and the Policy, Organisation and Rules of the Scout Association.

The Group is a trust established under the rules which are common to all Scouts. The Trustees are appointed in accordance with the Policy, Organisation & Rules of The Scout Association.

At the end of the year income reserves amounted to £173,398.

The accounts have been drawn up on a receipts and payments basis which is consistent with the previous year.
