Summary of the purposes of the charity as set out in its governing document	Para 1.17	<p>The object of Royal Air Force Leeming Officers' Mess is:</p> <p>'The promotion of military efficiency of the armed forces of the Crown by the provision and support of facilities and activities for the efficiency and wellbeing of Service Personnel'.</p> <p>This object presents the Trustee with wide powers, enabling them to provide charitable assistance to all elements of the Royal Air Force Community. Internal subsidy of Mess activities and grant-making are the Royal Air Force Leeming Officers' Mess principal means of delivering this charitable assistance.</p> <p>The Royal Air Force Leeming Officers' Mess has three aims set by the Trustee:</p> <ol style="list-style-type: none">1. Encourage esprit de corps by enabling serving Mess members to mix together in both formal dining situations and informal social activities to help keep Service traditions alive and encourage the wellbeing of the Mess community.2. Encouraging, supporting and facilitating the development of sport to raise standards and to promote the link to fitness, teamwork and personal development through sporting activity and opportunities.3. Supporting facilities and capital projects to enable the best possible provision for the Royal Air Force Leeming community.

Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	This Fund derives public benefit as it assists in providing Royal Air Force personnel with the necessary skills to carry out the Royal Air Force contribution to the defence of the United Kingdom and its interests. Service Funds are established for the benefit of Service personnel to promote military efficiency which underpins esprit de corps and team working. Service Funds help to encourage personnel to develop the character, spirit and attitude to face challenges and danger associated with military service. As a result, the Fund derives a benefit to the general public in helping to provide personnel who are motivated, have high morale and are willing to serve the needs of their country and that of its public at all times. The operating brief of the Officers' Mess is to fund, from available investment income, bar profits and members subscriptions, expenditure on the core items of formal functions, sport, and administrative costs.

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	<p>As part of the Annual Financial Planning process the Committee seeks the agreement of the membership in setting the level of subscriptions in the relevant membership categories. These subscriptions subsidise the formal functions, meet operating and maintenance costs as well as enabling the Mess to fund its grant giving activities. The level of subscriptions was adequate to enable the Mess to fund its planned commitments.</p> <p>The Officers' Mess operate a bar as a primary purpose trading activity. The Financial Plan put in place a Gross Percentage Profit for both the bar and cellar (Bar GPP 25%, Cellar GPP 15% & Sundries 10%) to enable sufficient funds to be generated to fulfil its subsidy, fund and grant commitments.</p> <p>The charity provided grants and financial subsidies to official and non-official events totalling £33,114.80. This included £10,388.63 which funded the Christmas Draw and £19,826 which funded the Summer Ball. Both events provide a social celebratory evening to all RAF Officers on RAF Leeming as well as any guest they wish to bring – often dependants and friends, providing a wider societal benefit.</p>

		<p>The charity provided grants to external organisations and funds totalling £5,250. This included £3000 which contributed towards the Station Families Day, an annual event for Service personnel to host their families at their place of work in a relaxed and social setting. £250 was granted to the Vulnerable Adults Dinner and £2000 was granted to the Station Annual Reception, an event which brings in members of the local community to strengthen ties and thank them for their continuing support for RAF Leeming and its activities.</p> <p>£9,363 was spent improving the quality of life at the Mess and refreshing the decor. Most work was conducted through self-help removing the need to spend additional money on labour, this included installing and funding free Wi-Fi in communal areas of the mess as well as developing the communal garden area.</p>

An Entertainments financial plan is provided which details a breakdown of each subsidy allocated to an event and is ratified by the members. Other financial items which are separately ratified by the members at the EGM include all Subscription Charges, Gross Profit Percentages and Power of Expenditure for the Committee. All grants are presented and approved on individual basis. All the above are included in the main body of the financial plan which is the final item in its entirety to be accepted and ratified by the Mess members.</p> <p>The Annual General Meeting ratifies the previous years' Annual Audited Statement of Financial Activities & Balance Sheet of the Mess. They are circulated to reach the Trustee within 10 working days of the meeting for his approval.</p>


