Section 2 Activities and Achievements

Activities and achievements of the charity during the year in relation to the objects :

The Jainagar Trust's (JT) major activities in 2023/24 have continued to centre on our main charitable objects: to relieve physical hardship and sickness and to improve the quality of life and future opportunities of a particular group of needy women and girls originally orphaned in Gorakhpur in Northeastern India that we have traditionally sought to serve since the charity was founded.

Specifically, the charity has been supporting the Gorakhpur Nurseries Fellowship (GNF) Orphanage for 50+ girls and adult women in Gorakhpur, India who were abandoned as babies or children for a variety of reasons by their birth parents. The Nurseries have been run for years on the model of a large Christian family and community originally led by UK missionaries from the 1920s onwards and now recently by indigenous Indian Christian staff. The Trust pays towards the housekeeping, education and training of those living in the GNF. When qualified, some women leave to live independently, some marry and set up their own Christian homes and families and some remain in the Nurseries to help with its day to day running as buas. There are many stories of individual girls and adults being helped and supported by the JT to obtain educational, professional and practical qualifications to enable them to live independently. These accounts are communicated through a regular newsletter that is sent to donors, contacts and interested parties.

During 2023 it became increasingly clear that the future of the Nurseries is changing and the current provision of facilities on the site to meet new needs was outdated and must be redeveloped. The number of abandoned babies and children brought to the GNF has markedly decreased because of new Indian legislation and social services support for families in need. The existing residual community has declined in number partly as a result of this, and also because young women have left after obtaining work qualifications without new babies or children replacing them. To address the new circumstances the Indian Board of GNF trustees have sold some of the extensive GNF community grounds and are currently using part of the sale proceeds to build a combined health clinic and small hospital, and a junior school on another area of land within the retained grounds, to help meet current Indian local government expectations. The JT has not been involved in the funding of these new projects but both are expected to be ready for use by the end of 2024/early 2025.

In view of these changes, Jainagar trustees have been working closely with the GNF Chair, Rev Girish Chandra, and other Indian trustees, to discuss what the future role and involvement of the JT should be in the continuing care of the ageing women and girls still living in the original Nurseries, and people using the new medical and school facilities being built.

JT trustees have made various successful trips to Gorakhpur during the year including one formal visit in late March 2023 by the Chair, Rev Robert Donald, and the Treasurer, Roland Panek. They met Rev Girish Chandra, Chair of the GNF Trust, viewed the progress of the different building projects, agreed new budgeting arrangements and other operational policies for the existing Nurseries and discussed the role of the JT, if any, in the running and functioning of the new facilities under construction. Informal visits were also made to the GNF by two trustees on separate occasions in 2024.

Some further small improvements and repairs have been made to the existing GNF communal buildings during the year to modernise kitchens, toilets, shower rooms, bedrooms, dining area and staff accommodation. However the much overdue major refurbishment work and rebuilding that is urgently needed to ensure the Nurseries meet the 21st century Indian standards, now rightly expected for such charitable work, has been deferred. This redevelopment was raised during the Chair's 2023 formal visit and will begin when the JT has agreed with the GNF trustees its future role and support for the existing women and girls in the original Nurseries' community and for any new similarly needy children and/or adults who may be provided for in a completely new build Nurseries' development which is now proposed. This would mean many or most of the current communal buildings will be demolished to make room for this.

Much of our trustees' time over the last year has been taken up with discussing the outcome of virtual Zoom meetings held with the Rev Girish Chandra and his son Mr Amreesh Chandra, on how the construction and running of this new facility will be funded and the role that the GNF Trust expects the JT to play for financial support in the future. During 2024/25 our trustees will have to make a final decision about the extent of JT's future involvement in this project and depending on this outcome, Board members may have to consider a major fundraising initiative to increase the Trust's resources.

We have received and considered the accounts of the Gorakhpur Nurseries Fellowship for the years ended 31 March 2024. In the year under review, the JT received donations and grants of £11,615 (2023: £20,457) of which £Nil (2023: £7,584) was derived from overseas sources. In addition to this, the Trust received legacy donations of £15,000 (2023: £20,000) but this is non-recurrent income. The Trust made donations of £15,673 (2023: £38,013) in the year directly to support the day to day work and expenses of the existing Nurseries.

After other incidental expenditure, the Trust made a net surplus in the year of £11,118 (2023 surplus: £7,144). Net funds available as at 31st March 2024 were £88,004 (2023: £76,886).

Expenses continue to exceed general donation receipts (excluding Legacies). Trustees have agreed a policy to cap the monthly support grant sent to the Nurseries at approximately £2,000 per month until the treasurer receives more detailed monthly budget information on the GNF income and expenditure than currently received. JT are working with the Gorakhpur Nurseries Fellowship to identify the appropriate level of core funding to be provided from the UK, given that the GNF has healthy financial resources at present while the JT has a reducing balance. Currently, the Trust holds a substantial amount in their deposit account. In addition to funding the expenditure deficit, this is being retained to meet anticipated future needs for major building works and a refurbishment programme for the Nurseries in India as previously described. The Trust has advised the Chair of the GNF that over time their Trust will need to become revenue self-supporting in view of the current political attitude in India to block external Christian charitable funding of Christian projects in the country.

Financial Review

We have received and considered the accounts of the Gorakhpur Nurseries Fellowship for the years ended 31 March 2022 and 2023.

In the year under review, the Jainagar Trust received donations and grants of £20,457 (2022: £14,348) of which £7,584 (2022: £Nil) was derived from overseas sources. The Trust made donations of £33,013 (2022: £38,347) in the year directly to support the work of the GNF.

After other incidental expenditure, the Trust made a net surplus in the year of £7,144 (2022 deficit: £24,175). Net funds available as at 31st March 2023 were £76,886 (2022: £69,742).

Expenses continue to exceed general donation receipts (excluding Legacies) and trustees have agreed a policy to cap the support grant at approximately £2,000 per month and are working with the Gorakhpur Nurseries Fellowship to identify the appropriate level of core funding to be provided from the UK, given that they have healthy financial resources at present and the reducing balance of the Trust's own funds. Currently, the Trust holds a substantial amount in the deposit account. In addition to funding the deficit, this is being retained to meet anticipated future needs for major building works and a refurbishment programme for the Nurseries in India. The Trust has advised the Chair of the GNF that over time their Trust will need to become revenue self-supporting in view of the current political attitude to external Christian charitable funding India.

Section 2 Activities and Achievements

- Activities and achievements of the charity during the year in relation to the objects : The financial results are set out on pages 1 and 2 above.
- Throughout the year under review the principal activities have been to relieve sickness and to relieve financial hardship.

Specifically, the charity has been supporting the Gorakhpur Nurseries Fellowship Orphanage for girls and adults in Gorakhpur, India. There are many stories of individual girls and adults being helped and supported, which are communicated through a regular newsletter that is sent to donors and interested parties.

The trustees have continued to develop their collaborative working relationship with the Gorakhpur Nurseries Fellowship Board of Trustees. Trustees have not visited the Nurseries during the last two years, mainly due to the Covid 19 pandemic. There are on-going discussions with the Board as to improvements in personnel, policies and practices at the Gorakhpur Nurseries. Property improvements have continued to take place. We have received and considered the accounts of the Gorakhpur Nurseries Fellowship for the year ended 31 March 2020.

In the year under review, the Trust received donations and grants of £34,659 (2020: £42,495) of which £10,228 (2020: £14,350) was derived from overseas sources. The Trust made donations of £62,605 (2020: £57,664) in the year directly to support the work of Gorakhpur Nurseries Fellowship Orphanage in India.

After other incidental expenditure, the Trust suffered a net deficit in the year of £28,591 (2020: £28,019). Net funds available as at 31st March 2019 were 93,917 (2020: £122,508).

Expenses are continuing to exceed receipts. Currently the Trust holds a substantial amount in deposit account. In addition to funding the deficit, this is being retained in order to meet anticipated future needs for major building works. It is expected that over time Gorakhpur Nurseries Fellowship will become self-supporting in view of the attitude to external funding in India.

Section 3 Public Benefit

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning future activities. The trustees are also aware of the Charity Commission's guidance on public benefit in The Advancement of Religion for the Public Benefit and have had regard to it in carrying out the activities described in this report during the year ended 31 March 2021

The trustees confirm that they have complied with their duties under section 17 of the 2011 Charities Act with regard to public benefit.
