Report of the Trustees
for the year ended 31 December 2022

The trustees present their report with the financial statements of the charity for the year ended 31 December 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The acquisition, preservation and restoration of historic fairground organ for the benefit of the public.

Significant activities

The Trust's fundraising activities continued throughout 2022.

Despite the pandemic continuing to effect public events in 2022, the Trust was able to exhibit the restored 89 key Marengi (ex-Reeders) organ at events in Hertfordshire, Derbyshire, Cambridgeshire, Cornwall and Worcestershire. Weekly recitals of the organ took place on Friday evenings, and throughout weekends, at the Trust's industrial unit in Milton Keynes.

Work continued on the restoration of the Trust's 89 key Marengi organ (ex-Middleton).

Facade restoration and decoration continued using the skills of a specialist Belgian woodcarver and decorator.

The Trust continued to acquire new and second-hand music books for both 89 VB and 89 G4 scales. The Trust's ongoing project to repair and recut old and damaged music increased in scope in 2022..

The Trustees supervised these restoration work streams with visits, calls and emails.

Public benefit

The public benefits from the activities of the Trust because it is one of the few charitable organisations in the world which commits significant resources and expertise to the rescue, restoration and maintenance of historic and original fairground organs. An important element of fairground heritage is therefore preserved for the benefit of the public. As one of the Trust's instruments, an 89 key Marengi (ex-Reeders), is exhibited and played at public events, significant numbers of people can listen to, and inspect the working parts of, a historic and restored fairground organ.

FINANCIAL REVIEW

Reserves policy

The Trust aims to maintain sufficient reserves in the event that donations to the Trust fall and replacement funding cannot be obtained.

FUTURE PLANS

The Trust will continue its extensive restoration process in respect of the organs in its care, which include instruments by Gavioli, Marengi, Hooghuis, Pierre Eich and Gasparini. The Trust will continue to travel one of its 89 key Marengi organs to a full season of events.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust and constitutes an unincorporated charity.

Recruitment and appointment of new trustees

One Trustee was appointed during this financial year.

Organisational structure

The Trust is governed by a voluntary Board of Trustees. As at the end of 2021, the Trust comprised three Trustees who were responsible for ensuring the Trust fulfils its responsibilities in relation to charitable law. The Chairman oversees the strategic and operational management of the Trust and reports to the other Trustees on a regular basis.

Induction and training of new trustees

In the event that new Trustees are appointed, then they are provided with an update on the progress of the Trust and any other relevant information. Training of Trustees is provided where necessary.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
