Summary of the objects of the charity set out in its governing document

The objects of the charity are set out in our Trust Deed as follows:

- To relieve poverty and sickness of persons suffering in the UK and overseas.
- To advance the education of persons in the UK.
- To relieve persons in need from the Muslim community in the UK, particularly by advice and support services.
- To promote and advance the religion of Islam.

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

The Trust carries out a range of activities in pursuit of our charitable objects as outlined above. Our activities assist beneficiaries within our areas of operation in addition to the wider community, in compliance with the requirements of section 4 of the Charities Act 2006 i.e. to have due regard to public benefit.

In 2023, fundraising events and delivery of our regular projects continued to be significantly impacted by the shutdown of our premises and loss of volunteers during lockdown. However, we continued to hold weekly Islamic Studies classes via Zoom.

Supplementary School (Slough)

The Trust first offered Islamic Studies classes in 2004 at hired facilities within the Slough area. From 2013 until 2022, the Chair provided the Trust with the use of a premises free of charge to carry out charitable activities including weekly classes. During lockdown in 2021, we were able to move some classes to Zoom and continued to deliver the following classes online into 2023 albeit with reduced attendance:

- Weekly *Tafsir* (interpretation of the Holy Qur'an) classes, free of charge, attended by six to ten women.
- Islamic Studies classes for children aged 7-13 years three times per week.

Use of premises

- As the premises was not in use during lockdown for an extended period, the Chair person sold the building in February 2022 and made a significant donation to the Trust from the sale proceeds.

Charitable Projects (UK)

Each year, the Trust donates Christmas hampers to the homeless Look Ahead hostels in Slough and Maidenhead. In 2023, we donated 22no. hampers containing bedding, warm clothes, food and toiletries to the Slough Lookahead Hostel residents.

Charitable Projects (Overseas)

The Trust previously funded a number of long term poverty relief initiatives in Pakistan in partnership with local registered NGOs. The following activities were undertaken which are continuing to sustain the beneficiaries:

- **Zakat distribution (a form of specific charitable giving, regulated in accordance with the Qur'an).** In previous years, we have invested in micro-finance initiatives, including start up funds and interest free loans for small businesses in partnership with the Saylani Welfare Trust International (registration no. 1145851). In 2013, we awarded 50 families with auto rickshaws worth around £1200 each on an interest free loan basis. Recipients were required to make a small initial deposit followed by 24 monthly interest free payments. The recipients repaid their loans and now own the rickshaws outright. In 2014, we froze additional investment in the microfinance initiatives to focus on new projects, however ongoing repayments have continued to sustain the auto rickshaw scheme.
- In 2023, we also raised funds for the Syrian Earthquake Appeal following the devastating earthquake in Turkey and Syria. We donated 50no. tents to Global Helping Hands, a local registered charity, that was delivering emergency relief essentials to Syria by road.

Policy on Grantmaking

We regularly receive donations from the public for the following:

- Charitable projects in the UK
- Poverty relief work overseas
- *Zakat*
- *Sadaqah*

Our policy on grantmaking is based on utilising donations as effectively and transparently as possible. Until lockdown, each year we were holding an annual event to which donors are invited to view progress with our projects in Pakistan.

Overseas, we only work alongside established and registered organisations that are locally based, which in previous years have included Islamic Relief, Save the Children and the Saylani Welfare Trust International. Until 2018, the Chair Person would make a self-funded trip to Pakistan annually to oversee the Ramadan project and the Orphan Sponsorship Programme.

In the UK, prior to awarding a grant, at least two trustees visit the applicant to verify information provided on the application and confirm alignment with the Trust's objectives.

Contribution by Volunteers

Since the charity's establishment in 2004, a core team of volunteers regularly donate all of their time free of charge, often in the evenings and at weekends. Our volunteers also contribute to their own expenses and to those of the Trust, providing free supplies for the day to day running of the charity.

We have an expenses policy in order to reimburse volunteers for reasonable expenses incurred on the charity's behalf. The expenses are covered using funds raised from the sale of homemade food, fairtrade goods and school fees. This allow 100% of donations to go towards projects whilst ensuring that financial constraints do not prevent volunteers from participating in our work.

The main achievements of the charity **during 2023** are summarised below:

- 50no. brand new tents purchased and donated to Syrian Earthquake Appeal.
- Donated 22no. Christmas hampers to Slough Lookahead Homeless hostel.
- Pakistan based micro-finance project providing auto rickshaws on an interest free loan basis continued to self-fund itself.



The financial statements have been prepared under the historical cost convention.

Income



The Trust carries out a range of activities in pursuit of our charitable objects as outlined above. Our activities assist beneficiaries within our areas of operation in addition to the wider community, in compliance with the requirements of section 4 of the Charities Act 2006 i.e. to have due regard to public benefit.

Supplementary School (Slough)

The Trust first offered Islamic Studies classes in 2004 at hired facilities within the Slough area. From 2013, the Chair Person provided the Trust with the use of a premises free of charge until such time that the Trust can raise sufficient funds to purchase its own building.

From March 2020, due to Covid-19, all classes at the premises were temporarily suspended and subsequently the Trust moved classes to Zoom. The following classes continued into 2022:

- Weekly *Tafsir* (interpretation of the Holy Qur'an) classes, free of charge, attended by approximately ten women.
- Islamic Studies classes for children aged 7-13 years. Approximately six students attended three times per week on Zoom.

Use of premises

- Due to the premises not being in use during lockdown and all classes continuing to take place via Zoom post lockdown, the Chair person sold the building in February 2022.

Charitable Projects (UK)

Each year, the Trust donates Christmas hampers to the homeless Look Ahead hostels in Slough and Maidenhead. In 2022, we donated 22no. hampers containing brand new duvets, bed sheets, toiletries and food to the Slough Lookahead Hostel residents.

Charitable Projects (Overseas)

The Trust funds a number of long term poverty relief initiatives in Pakistan in partnership with local registered NGOs. The following activities were undertaken:

- **Zakat distribution (a form of specific charitable giving, regulated in accordance with the Qur'an).** In previous years, we have invested in micro-finance initiatives, including start up funds and interest free loans for small businesses in partnership with the Saylani Welfare Trust International (registration no. 1145851). In 2013, we awarded 50 families with auto rickshaws worth around £1200 each on an interest free loan basis. Recipients were required

to make a small initial deposit followed by 24 monthly interest free payments. A number of recipients have now repaid their loans and own the rickshaws outright. In 2014, we froze additional investment in the microfinance initiatives to focus on new projects, however ongoing repayments have continued to sustain the auto rickshaw scheme.

Policy on Grantmaking

We regularly receive donations from the public for the following:

- Poverty relief work overseas
- *Zakat*
- *Sadaqah*
- *Qurbani*

Our policy on grantmaking is based on utilising donations as effectively and transparently as possible. Until lockdown, each year we were holding an annual event to which donors are invited to view progress with our projects in Pakistan.

Overseas, we only work alongside established and registered organisations that are locally based, which in previous years have included Islamic Relief, Save the Children and the Saylani Welfare Trust International. Until 2018, the Chair Person would make a self-funded trip to Pakistan annually to oversee the Ramadan project and the Orphan Sponsorship Programme.

In the UK, prior to awarding a grant, at least two trustees visit the applicant to verify information provided on the application and confirm alignment with the Trust's objectives.

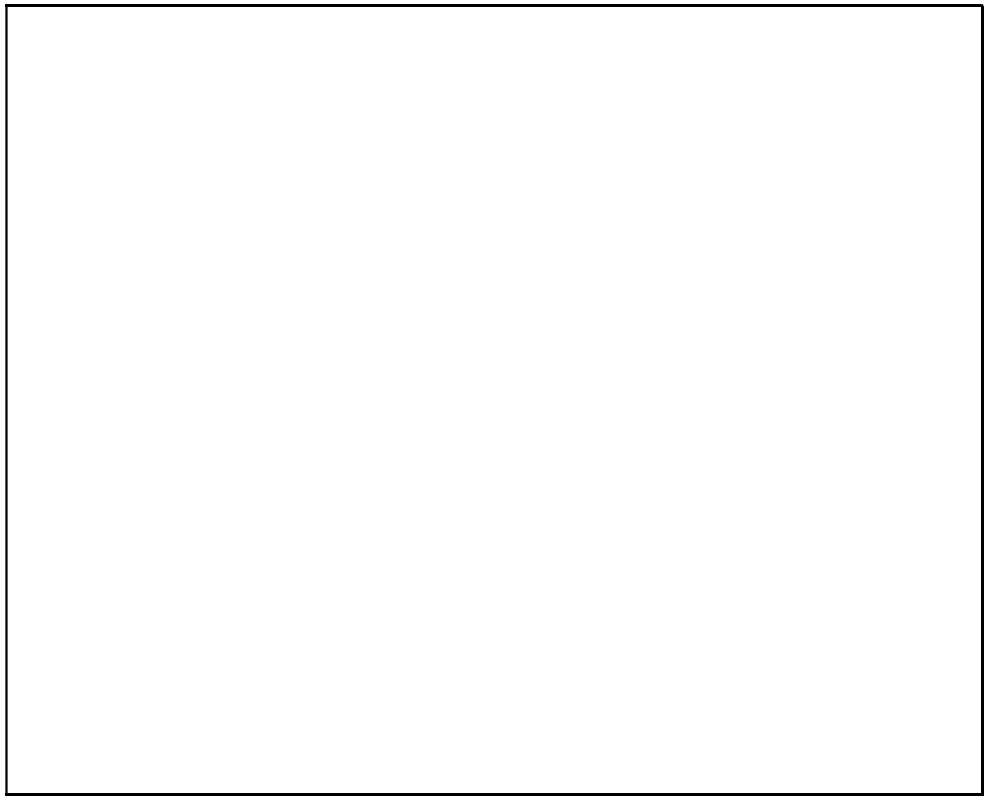
Contribution by Volunteers



- Islamic Studies classes for children aged 7-13 years. Approximately six students attended three times per week on Zoom. Three students from the previous year graduated in their studies.

Unfortunately, the special events that would normally take place throughout the year to coincide with significant religious events in the Islamic calendar did not take place in 2021 due to lockdown restrictions.

Use of premises

The Trust carries out a range of activities in pursuit of our charitable objects as outlined above. Our activities assist beneficiaries within our areas of operation in addition to the wider community, in compliance with the requirements of section 4 of the Charities Act 2006 i.e. to have due regard to public benefit.

In 2020, Covid-19 and the associated lockdown restrictions had a significant impact on our charitable activities from the cancellation of classes and fundraising events to the running of our regular projects.

Supplementary School (Slough)

The Trust first offered Islamic Studies classes in 2004 at hired facilities within the Slough area. Since 2013, the Chair Person has provided the Trust with the use of a premises free of charge until such time that the Trust is able to raise sufficient funds to purchase its own building.

From March 2020, due to Covid-19, all classes at the premises were temporarily suspended. In July, when it became apparent that lockdown may be a longer term situation, the Trust decided to hold classes over Zoom where possible.

The following classes took place until March 2020:

- Weekly Tajweed (recitation of the Holy Qur'an) classes, free of charge, attended by over 25 women.
- Islamic Studies classes for children aged 7-13 years, for which a one off admission charge and monthly fees were charged. Approximately twenty nine students attended classes four times per week.
- Weekend Qur'an and Hadith class for girls aged 12-14.

From July 2020, the following classes took place over Zoom:

- Weekly *Tafsir* (interpretation of the Holy Qur'an) classes, free of charge, attended by approximately ten women.
- Islamic Studies classes for children aged 7-13 years. Approximately nine students attended two times per week on Zoom, free of charge.

Unfortunately, the special events that would normally take place throughout the year to coincide with significant religious events in the Islamic calendar had to be cancelled due to lockdown restrictions.

Use of premises

- Following the completion of the extension to the premises in 2016, the Trust continued to make extensive use of the additional facilities for classes in early 2020.

- The Chair Person continued to allow the Trust to use the premises free of charge (inclusive of utility bills) for a seventh year running.

Supplementary School (Birmingham)

In early 2020, classes continued to be held on a monthly basis at the home of a local student. The classes were put on hold from February 2020 for the remainder of the year due to lockdown restrictions.

Events

This year, our regular annual events, including fundraisers and the 5 / 10k sponsored walk, were cancelled due to Covid-19 with a significant impact on fundraising.

Charitable Projects (UK)

Each year, the Trust donates Christmas hampers to the homeless Look Ahead hostels in Slough and Maidenhead. In 2020, due to Covid-19 and lockdown restrictions, our volunteers were unable to deliver this project.

Charitable Projects (Overseas)

The Trust funds a number of long term poverty relief initiatives in Pakistan in partnership with local registered NGOs. The following activities were undertaken:

- **Zakat distribution (a form of specific charitable giving, regulated in accordance with the Qur'an).** In previous years, we have invested in micro-finance initiatives, including start up funds and interest free loans for small businesses in partnership with the Saylani Welfare Trust International (registration no. 1145851). In 2013, we awarded 50 families with auto rickshaws worth around £1200 each on an interest free loan basis. Recipients were required to make a small initial deposit followed by 24 monthly interest free payments. A number of recipients have now repaid their loans and own the rickshaws outright. In 2014, we froze additional investment in the microfinance initiatives to focus on the new Orphan Sponsorship Programme, however ongoing repayments have continued to sustain the auto rickshaw scheme.
- **Qurbani (sacrifice of livestock during Eid ul-Adha and distribution of meat to the poor).** This year, we received donations for over eighty nine livestock which were distributed to the beneficiaries in Africa through our charity partner, the Al-Khair Foundation (UK registration no. 1126808). This was an increase of almost a third on the previous year.
- **Orphan Sponsorship Programme.** The Orphan Sponsorship Programme in Pakistan was established in 2015 in partnership with the local and highly reputable NGO, Sweet Homes Pakistan (Registered Foundation No. 1302/4). In 2019, we awarded a further grant to sponsor 100 orphan girls, funding their education, accommodation and welfare needs for the next two to three years. The girls continued to excel in their education with a number of students continuing their studies at one of Pakistan's top private schools following scholarship awards.

Advice & Support Services

- The Trust is a place where local women frequently drop in for a friendly chat and personal advice. Until lockdown, the Trust continued to provide confidential advice to women on family matters.

Overseas, we only work alongside established and registered organisations that are locally based, which in previous years have included Islamic Relief, Save the Children and the Saylani Welfare Trust International. Until 2018, the Chair Person would make a self-funded trip to Pakistan annually to oversee the Ramadan project and the Orphan Sponsorship Programme.

In the UK, prior to awarding a grant, at least two trustees visit the applicant to verify information provided on the application and confirm alignment with the Trust's objectives.

Contribution by Volunteers

Since the charity's establishment in 2004, a core team of volunteers regularly donate all of their time free of charge, often in the evenings and at weekends. Our volunteers also contribute to their own expenses and to those of the Trust, providing free supplies for the day to day running of the charity.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
