## FINANCIAL CONTROLS AND PROCEDURES OF GLOBE RANGERS FOOTBALL CLUB

Globe Rangers FC was set up in 1995 as a community based football club, and became a registered charity in August 2009.

The trust does not employ any administrators. It has a bank account held at Barclays Bank. The bank account is administered by the treasurer and their everyday processes include issuing cheques. There are two signatories. Any amounts to be paid exceeding £1,000 need to be agreed with fellow trustees prior to issue. The monthly bank statements are made available for scrutiny at every meeting.

The Club's main achievement is the maintenance and upkeep of a sports ground so it is available for the benefit of the local community.

It is difficult to think of any changes which would add further safeguards to the trustee procedures.
