The Financial Plan for 2022-2023 is positive and the potential further relaxing of COVID-19 restrictions will potentially increase the Mess income further.

This continued to restrict the charity's activities at the beginning of the financial year 2021/2022. However, since the autumn of 2021 the charity has regain the use of their premises and the bar has reopened, following HM Government's COVID-19 protocols.
