#### 1. ACCOUNTING POLICIES AND CONVENTION.

(a) The accounts have been prepared under the historic cost convention.

#### (b) Revenue.

Amounts received from donors in foreign currencies are accounted for at the rate ruling when the funds are received.

#### (c) Taxation.

The organisation is recognised as a charity for tax purposes.

#### (d) Fixed assets.

In line with normal accounting practice for NGOs and similar non-profit making and charitable organisations, fixed assets are not charged to a fixed asset capital account in the books of account at purchase. They are allocated to an appropriate expense account.
