**Activities:** AS FIRST SUBMITTED ON REQUEST TO BECOME A CHARITY TO ENCOURAGE COMMUNITIES OVER SIX COUNTIES WITHIN THE ANGLIA REGION TO ENHANCE THEIR ENVIRONMENT WITH THE USE OF FLOWERS AND ACTIVITIES THAT PROMOTE ENVIRONMENTAL CLEANLINESS, BIODIVERSITY AND SUSTAINABILITY.
