We organise 6 concerts annually, one per month from October to March. We have approximately 220 Season Ticket subscribers plus many people who buy tickets at the door for one off concerts.

Trustees' report for the year ended 30 April 2021

Objectives and Activities

The charity's objects

To advance, improve, develop and maintain public education in, and appreciation of, the art and science of music in all its aspects by any means the trustees see fit, including through the presentation of public concerts and recitals. To further such charitable purpose or purposes as the trustees in their absolute discretion shall think fit but in particular through the making of grants and donations.

The charity's main activities

The principal activity is the provision of high-class professional classical music concerts and recitals at a venue in Skipton, conceived of as primarily but not exclusively for the benefit of the inhabitants of Skipton and its neighbourhood. Typically six such events are organised annually, one per month from October to March, with tickets available either for the whole season or individually.

Public benefit statement

In setting its objectives and planning its activities the Trustees have given serious consideration to the Charity Commission's general guidance on public benefit and in particular on the advancement of the arts, culture, heritage and education.

Achievements and Performance

As a result of the Covid-19 pandemic Skipton Music has been unable to engage in its principal activity during the year 2020-21. It has however, bearing in mind the impact of the pandemic on the livelihoods of professional musicians, made a number of donations within the sector. It has also taken steps to keep its local audience informed both of its current actions and its plans for the future.

Financial Review

Financial position

In spite of the cessation of activity the net income for the year was £25,787.37. This is due to the receipt of a substantial bequest during the course of the year.

Reserves policy

The trustees have not adopted a reserves policy. The trustees consider it unnecessary to determine a policy, given the minimal level of normal annual outgoings.

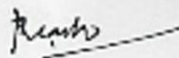
