Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	<p>During FY 21/22, COVID-19 continued to have impacts on the social calendar, but major events such as the Summer Ball and Christmas Draw were still run, albeit with costly COVID-19 mitigation measures implemented.</p> <p>Throughout the period, the committee have been given direction by the President of the Mess Committee and Mess Membership on how to improve the facilities, for not only its inhabitants, but all eligible personnel at RAF Waddington. We have funded numerous small-scale improvements throughout the Officers' Mess, such as a Pizza Oven, better outdoor spaces and furniture, renovation of armchairs and improvements to communal areas.</p> <p>We have also used historic underspends to further the heritage of RAF Waddington. This has been strengthened by the purchase of 2 x silver hallmarked aircraft models, owned by the Officers' Mess, as well as taking delivery of 1 of 3 new pieces of artwork. The models and artwork all represent current, in-service aircraft at RAF Waddington and therefore will showcase the RAF of the 20s for years to come.</p> <p>Due to the cost of living increase dramatically, we have had to increase the daily subs by 1p/person, meaning an increase of £3.65 per member for the whole year. This has, however, been coupled with a reallocation of entertainments monies to focus on smaller scale events, such as Families Happy Hours, designed to encourage young families and personnel back into the Mess after 2.5 years of COVID-19 restrictions.</p>

Performance of fundraising activities against objectives set	Para 1.41	The fund does not aim to generate income from investments; however, it did experience a favourable 12 months, even with COVID-19 presenting some mild risks. The impact of the pandemic and subsequent activity within the financial markets is yet to be realised; therefore, no action will be taken with investments. When the income from the Mess investments reaches over £5,000, the incumbent Treasurer and Mess team will review and discuss possible reinvestment or expenditure opportunities.

It is believed that the Officers' Mess financial position is strong yet in line with the Charities Committees' Direction.
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	<p>The Officers' Mess has a set value of funds allocated to Reserves.</p> <p>a. PMC fund. The PMC fund may be used by the PMC, normally with the consultation of the Mess committee, but does not require a consultation or vote to be passed. Examples where this might be utilised are rectification of urgent quality of life issues, or contribution towards the wake of any current or previous Mess members.</p> <p>b. Treasurer contingency. The Treasurer contingency fund may be used by the Treasurer, following consultation with the PMC and / or committee as necessary, to ensure individual accounts do not get unwillingly overspent. An example where this may be used is the provision of additional laundry facilities having spent the in-year budget.</p> <p>c. Mess Debt & Function Reserve Fund. This fund was agreed at the mid-year financial plan review and enabled the Mess Committee to have up to £3,000 to cover off historical long-term debtors, long-term function debts and miscalculations. For example, pers going long term sick or who have left the station over 4 years ago and where extensive tracking and investigation has led to no recovery of these funds.</p>
