**Objects:** THE PRINCIPAL PURPOSES OF THE FOUNDATION ARE, BY SUCH MEANS AS ARE CHARITABLE, THROUGHOUT THE WORLD AND MORE PARTICULARLY IN THE UNITED KINGDOM: (A) THE ADVANCEMENT OF THE FAITH AND RELIGIOUS PRACTICES OF ISLAM (B) THE ADVANCEMENT OF EDUCATION FOR THE PUBLIC BENEFIT CONCERNING THE TEACHINGS AND RELIGION OF ISLAM, AND (C) THE RELIEF OF POVERTY, SICKNESS, DISTRESS AND SUFFERING OF ANY PERSONS WHO ARE IN NEED IRRESPECTIVE OF THEIR NATIONALITY, RACE, ETHNIC ORIGIN AND RELIGIOUS BELIEFS, SEX OR SEXUAL ORIENTATION (D) TO PROMOTE THE BENEFIT OF THE INHABITANTS, IN PARTICULAR THE MUSLIM COMMUNITY, OF WALES WITHOUT DISTINCTION OF SEX, SEXUAL ORIENTATION, RACE OR OF POLITICAL RELIGIOUS OR OTHER OPINIONS, BY ASSOCIATING TOGETHER THE SAID INHABITANTS AND THE LOCAL AUTHORITIES, VOLUNTARY AND OTHER ORGANISATIONS IN A COMMON EFFORT TO ADVANCE THE MUSLIM FAITH, ADVANCE EDUCATION AND TO PROVIDE FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION AND OTHER LEISURE-TIME OCCUPATION WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR THE SAID INHABITANTS. (B) TO ESTABLISH OR SECURE THE ESTABLISHMENT OF A COMMUNITY CENTRE AND TO MAINTAIN AND MANAGE THE SAME, WHETHER ALONE OR IN CO-OPERATION WITH ANY LOCAL AUTHORITY OR OTHER PERSON OR BODY IN FURTHERANCE OF THE ABOVE OBJECTS

**Activities:** MCW is to work for the common good of the communities, building bridges and developing community cohesion, empowering the Muslim Community particularly youth and women. Building the capacity of the Mosques and other Muslim organisations with good governance, proper policies and continuous professional development.
