Activities

Objects: (I) THE RELIEF AND SUPPORT, INCLUDING THE PROVISION OF FINANCIAL ASSISTANCE, OF PERSONS SUFFERING FROM CANCER AND THEIR CARERS. (II) THE ADVANCEMENT OF INTEGRATED MEDICINE AND INCREASING THE ACCESS FOR THE WHOLE COMMUNITY TO IT, BOTH IN THE TREATMENT AND PREVENTION OF ILLNESS, BY: (A) THE EDUCATION OF THE MEDICAL PROFESSION AND THE GENERAL PUBLIC IN INTEGRATED MEDICINE AND PROACTIVE HEALTHCARE, (B) RESEARCHING AND SUPPORTING THE RESEARCH OF INTEGRATED MEDICINE AND PUBLISHING OR ASSISTING IN THE PUBLICATION OF THE RESULTS OF SUCH RESEARCH. (C) CARRYING OUT OF ANY OTHER LEGALLY CHARITABLE PURPOSES IN RELATION TO THE SUPPORT AND ADVANCEMENT OF INTEGRATED MEDICINE AND HEALTHCARE PROVIDED THAT IN EVERY CASE THE PURPOSE IS WHOLLY CHARITABLE AND FOR THE PUBLIC BENEFIT IN THIS CLAUSE THE EXPRESSION "INTEGRATED MEDICINE" IS DEFINED AS A HOLISTIC APPROACH TO HEALTHCARE BOTH ON THE TREATMENT AND PREVENTION OF ILLNESS THAT UTILISES CONVENTIONAL MEDICINE, COMPLEMENTARY MEDICINE, ALTERNATIVE MEDICINE, NUTRITION AND SELF HELP TECHNIQUES

Activities: The charity is working to widen access for the whole community to Integrated Medicine by supporting the education of medical professionals and students and by providing funding for cancer patients with limited financial means to undertake doctor led Integrated Medicine programs.
