Legal structure of the charity

The charity is constituted as a company limited by guarantee, registered under the Companies Acts . The governing document of the charity is the Memorandum and Articles of Association establishing the company under company legislation.

There are no restrictions in the governing documents on the operation of the Charity or on its investment powers other than those imposed by Charity Law.

By operation of law all, trustees are directors under the Companies Act 2006 and all directors are trustees under Charities legislation and have responsibilities, as such, under both company and charity legislation.

The trustees are all individuals.

Objects and activities of the charity

The purposes of the charity as set out in its governing document.

The purpose of the Didier Drogba Foundation as set out in the objects contained in the company's memorandum of association continues to be focussed on Health and the provision of Education. The foundation will help to improve access to health and education in Ivory Coast.

In 2007, a Foundation was founded in Ivory Coast by Didier Drogba for the provision of healthcare and education for the people of Africa. To help support the very ambitious project of building a clinic and maintaining it into the foreseeable future, the Didier Drogba Foundation was set up in the UK to work with the one in Ivory Coast mainly to help fundraise and create more awareness of the projects in Africa.

The Didier Drogba Foundation aims to provide financial and material support in both health and education. Currently the primary objective of the charity is to operate a fully functional hospital in Abidjan the capital city of Ivory Coast. The fully functional unit will provide medical and nursing care services to the general public.

The charity will also be operating a mobile clinic that will provide access to very remote areas via a modified vehicle. The mobile clinic is equipped with basic medical facilities that will provide initial support and care to the people living in the remote areas and do not have access to readily available medical facilities.

The main activities undertaken in relation to those purposes during the year.

Health and Education is an integral part of the Foundations work, The COVID-19 global pandemic continued to bring challenges with health care throughout 2021 in Ivory Coast and especially in the vulnerable, rural localities of the country, however In January 2021, the Didier Drogba Foundation started the new year by offering computers, computer tool training software, headphones, printers, inverters and a 1-year internet connection to Primary Public School 1 in Niablé and the Nanan Kouakou Kouao High School in Niablé. The Didier Drogba Foundation also donated A hundred ZECI solar bags containing school kits to the students of the Community School of the village of Aboudou in support of the Individual Education Plan of Niablé. Alongside the IPPON Technology Foundation, the Didier Drogba Foundation continue to work to curb the digital divide in Africa, especially in Côte d'Ivoire. Towards the end of 2021, the EPP Anne Hidalgo 1 and 2 schools in Brofodoume and those in Ahué benefited from computers, printers and a one-year high-speed connection to the Internet.

In September the Didier Drogba Foundation signed a memorandum of understanding with the World Tourism Organization in the presence of Mr. Zurab Pololikashvili, Secretary General of the Organization and Didier Drogba President of the Foundation.

The partnership aims to highlight the potential of African youth and ensure that tourism and sport utilize their potential to offer opportunities to all.

Compliance with road safety rules relating to pedestrians, motorists and motorcyclists, was organized by the Prudence Foundation and Didier Drogba Foundation on Tuesday, October 26, 2021 in the gardens of the Lepic residence. During the exchanges, the president of the foundation reiterated his commitment to this cause and encouraged bloggers to convey good practices in road safety through their channels.

The main activities undertaken during the year to further the charity's purpose for the public benefit.

During the year, the Didier Drogba Foundation have served those in remote and vulnerable areas of Ivory Coast via the mobile clinic with The Heart Fund. The mobile clinic, a modified and equipped vehicle, is operational and able to provide medical services to the inhabitants in the remote areas it visits. Donated digital equipment and teacher training to schools has been paramount in its endeavours to support the people of Ivory Coast.

The contribution of volunteers during the year.

All the work of the foundation in the UK is carried out by volunteers.

The main achievements and performance of the charity during the year.

Didier Drogba Foundation Trustees' Report For the year ended 30 November 2021

During February 2021 at Holy Faith School Group in Abobo, Didier Drogba Foundation and NGO Africa save Africa joined forces to serve the most vulnerable offering quality care in the form of a mobile clinic. Students, parents of students and administrative staff at The Sainte Foi d'Abobo School Group was the first institution to benefit from the care, with the foundation offering dental, ophthalmological care, consultation and screening sessions for cardiovascular diseases. A series of psycho-social, educational and sports activities were also offered to students to promote the importance of good health through education and sport.

The Didier Drogba Foundation and the NGO ASA intend to make their partnership long-term in order to have a strong and concrete impact on the Ivorian population. The teams have been travelling the country to help people in the most remote, marginal and in fact most fragile areas.

The Heart Mobile clinic continues to travel to villages where people have no access to healthcare, where they screen children, train doctors, and educate people on cardiovascular diseases.

The difference the charity's performance during the year has made to the beneficiaries of the charity.

The Didier Drogba Foundation continues to donate digital equipment and teacher training in the communes of Abidjan, Bassam, Cocody and Bingerville. Under the auspices of the Didier Drogba Foundation and partners Ippon Technologies, thousands of children now have access to digital education in their local areas. Computer equipment, reliable software packages, internet connection and training for teachers will help break the digital barrier in the Ivory Coast.

Didier Drogba, the foundations president, was appointed World Health Organization (WHO) Goodwill Ambassador for Sport and Health during 2021. The retired Ivorian footballer will help the UN World Health Agency to "promote its guidance on the benefits of physical exercise and other healthy lifestyles, and to raise awareness of the value of sport, especially among young people"

The degree to which the achievements and performance during the year have benefited wider society.

In June 2021 a partnership was formed with 01 Talent, uniting them and the Didier Drogba Foundation to transform the educational landscape and the African tech ecosystem with the ambition to identify the digital talents and entrepreneurs of tomorrow and become drivers of the continental tech ecosystem. The values of sporting success and surpassing oneself to reach a level of excellence that are carried by Didier Drogba and his Foundation, are perfectly reflected in the educational model carried by 01 Talent Africa. It is because the Didier Drogba Foundation and 01 Talent Africa share this vision of a fairer, more inclusive world in which diversity is a resource that they have chosen to build this partnership. The partnership aims to train and connect to the professional world with 1 million young talents in the next 10 years and the pledge is to set up more than 100 Collective Intelligence Zones ("Zone 01"), real Talent accelerators which include in particular;

- A coding, computer engineering and innovation learning establishment, without a teacher, without courses, without tuition fees and without academic prerequisites, according to the pedagogy invented by Nicolas Sadirac who has already trained more than 100,000 very high-level collaborative talents today

- A professional training area intended to support the digital transformation of local and regional companies via "reskilling" & "upskilling" programs

- A Talent Agency that will support the career of "01Talent" from coding learning zones with companies in the partner ecosystem The first Zone01 on the continent will be inaugurated in Praia, Cape Verde in September 2021 and will welcome 300 young talents from Cape Verde and 26 other African partner countries. These talents will be selected on their potential and their motivation then will follow a peer to peer 01Edu educational course, training in 2 years in the professions of code and digital innovation. The Didier Drogba Foundation and 01Talent Africa are committed in partnership with the umbrella organisation of African local governments UCLG Africa, to support the growth of the digital economy through the development of exceptional entrepreneurial skills.

Structure, governance and management of the charity

The UK foundation was formed on 5th November 2009 and it is currently made up of four trustees. The foundation's trustees who are also directors of Didier Drogba Foundation for the purposes of company law are responsible for the preparation of financial statements in accordance with the Companies Act 1985 and United Kingdom Accounting Standards

The trustees are all members of the Board and meet regularly. If required, the board meet more frequently and where necessary a subgroup is set up as needed to progress specific projects. The Board is responsible for all the strategic direction and policy of the foundation, its governance and financial management. As a result, all recommendations from the subgroup(s) are reported back to the full Board meeting for final decisions to be made.

The methods used to recruit and appoint new charity trustees.

The trustees form the board of trustees and are also directors of the company for the purposes of company law. A copy of the Charity Commission guide and other materials are made available to new trustees to help with the role.

The foundation is the brainchild of and mainly financed personally by Mr Didier Drogba. Due to the unique setup of the foundation and the nature of the charity's work, the foundation holds a steady board so as to manage and deliver the foundations aims and objectives. No other outside party is entitled to appoint new trustees. In view of meeting the skills set needed for the foundation, it has as far as possible maintained a broad range of skills within the Board of Trustees.

Trustees are entitled and encouraged to claim expenses, but none have done so to date. Highlighted at the beginning of each meeting is the need for trustees to disclose any interest on matters on the agenda. Trustees are required to disclose relevant interests and register them with the Board and in accordance with the DDF policy withdraw from decisions where a conflict of interest arises.

The charity's relationships with related parties.

The foundation maintains a healthy relationship with other likeminded charities and other third parties without affecting the stability and focus of the foundation. This year we have successfully completed projects in health, education and tourism through partnerships with the IPPON Technologies, World Tourism Organisation, the Global Partnership for Education, 01 Talents, Environmental as well as pre-existing partnerships with The Heart Fund, Defence Fund, Prosuma Group, Africa-Europe Alliance and Magic System Foundation These relationships have helped us in meeting our aims and objectives, particularly during the unprecedented public health crisis experienced around the globe throughout 2021.

The UK arm of the Foundation runs fundraising through JustGiving.com and relies of generous donations from members of the public.

1 Accounting policies

Policies relating to the production of the accounts.

Basis of preparation and accounting convention

The accounts have been prepared on the accruals basis, under the historical cost convention, and in accordance with the Financial Reporting Standard 102, (effective 1st January 2016) and 'FRS 102 SORP (Statement of Recommended Practice for Accounting and Reporting by Charities) 2015, (as amended by the Bulletin issued in February 2016), (The SORP), published by the Charity Commission in England & Wales (CCEW) , effective January 2016, , and in accordance with all applicable law in the charity's jurisdiction of registration, except that the charity has prepared the financial statements in accordance with the FRS 102 SORP (Statement of Recommended Practice for Accounting and Reporting by Charities) 2015, (as amended by the Bulletin issued in February 2016), (The SORP), in preference to the previous SORP, the SORP 2005, which has been withdrawn, notwithstanding the fact that the extant statutory regulations, the Charities (Accounts and Reports) Regulations 2008 refer explicitly to the SORP 2005. This has been done to accord with current best practice.

There has been no change to the accounting policies (valuation rules and methods of accounting) since last year.

Risks and future assumptions

The charity is a public benefit entity.

Policies relating to categories of

Nature of income

Gross income represents the value, net of value added tax and discounts, of goods provided to customers and work carried out in respect of services provided to customers.

Categories of Income

Income is categorised as income from exchange transactions (contract income) and income from non-exchange transactions (gifts), investment income and other income.

Income from exchange transactions is received by the charity for goods or services supplied under contract or where entitlement is subject to fulfilling performance related conditions. The income the charity receives is approximately equal in value to the goods or services supplied by the charity to the purchaser.

Income from a non-exchange transaction is where the charity receives value from the donor without providing equal value in exchange, and includes donations of money, goods and services freely given without giving equal value in exchange.

Policies relating to expenditure

Allocating costs to activities

Direct costs that are specifically related to an activity are allocated to that activity. Shared direct costs and support costs are apportioned between activities.
