### Structure, Governance and Management

Gateway Church, Poole is a charitable company limited by guarantee. It is governed by the Memorandum and Articles of Association and was incorporated on 15 March 2010.

The charity trustees are all directors of the charitable company and are appointed by ordinary resolution of the members as set out in articles 31 to 35 of the Memorandum and Articles of Association.

### Objects and Activities

Gateway Church, Poole is Bible-based, lively church serving Poole and the surrounding area with the good news of the Lord Jesus Christ. It also supports and assists mission in other parts of the UK and overseas. Being part of the Newfrontiers network of churches is its focus for achieving this.

The charity's objects are specifically restricted to the following:

- (a) to advance the Christian faith in such ways and in such parts of Poole, the United Kingdom or the world as the trustees from time to time may think fit;
- (b) to relieve sickness and financial hardship and to promote and preserve good health by the provision of funds, goods or services of any kind, including through the provision of counseling and support in such parts of Poole, the United Kingdom or the world as the trustees from time to time may think fit;
- (c) to further Christian education including but not by way of limitation to children of pre-school age in such parts of Poole, the United Kingdom or the world as the trustees from time to time think fit;
- (d) to provide or assist in the provision of facilities in the interests of social welfare for the recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disability, financial hardship or social circumstances with the object of improving their conditions of life in such parts of Poole, the United Kingdom and the world as the trustees may from time to time think fit.

### Annual Report

#### Our Vision and Values

We exist to preach the good news of Jesus Christ, to faithfully do justice to the instructions given to us through His word, the Bible, and to see as many people as possible impacted by this good news.

In doing this, three words sum up our values, and our goal is to be a people who live in a way that reflects the values encapsulated in these 3 words. Our plans and goals need to reflect:

**Adventure:** At the heart of the Christian faith is a great adventure to 'go to the ends of the earth' in proclaiming the good news of Jesus Christ. The bible is jam-packed with stories of adventurous men and women risking all, and at times sacrificing all, to see people come to salvation through Jesus. We desire to live as modern day adventurers for Jesus in just the same way!

**Purity:** Being people who are committed to honesty, integrity and faithfulness in everything that we do and say. Serving one another and serving God with clean hearts and clean hands.

**Compassion:** The sound of war, famine, sickness and death in our world should move us to compassion, and therefore action, in offering support and action to those around us. This means serving locally and further afield to see social ills alleviated and people set free from the pain and isolation of social, financial, personal or spiritual hardship.

#### Covid-19 and Gateway's Activities

The period that covers this annual report was marked by the national recovery to UK society following the 3 national Covid 19 lockdowns. These lockdowns required churches to shut their doors for significant periods and ran alongside a 20% shrinkage in the UK economy. Accordingly, self-funding charities like ours have faced significant challenges in recovering from these national measures.

The paragraphs below set out our activities for the period from April 2021 to March 2022.

#### Sunday Mornings

Usually on Sunday mornings we enjoy meeting together for worship and teaching. Our Sunday meetings are relaxed, informal and relevant to modern life. We have tea and coffee before and after our meetings. We worship God together and give time for a talk applying the truth of the Bible to life following which there is an opportunity for people to respond to what has been taught.

We operate as 'one church on two sites' with a congregation based at Alder Road, and another on Ashley Road in Poole. As we recovered from the impact of the national lockdowns, like many of the churches nationwide, we made it a priority to gather those who are members of the church, as well as being open for guests.

Having instituted a rigorous portfolio of pastoral care activities and online points of connection throughout lockdown, our congregation returned to in-person gatherings relatively quickly, although a small minority have chosen not to return and connect with the church via our weekly live-stream. Largely this has been older or more infirm people who we continue to maintain regular contact with.

At the beginning of 2022 we also entered into a building project to rebuild our Alder Road based buildings. This meant that we had to move both congregations into our facility on Ashley Road, and hold 3 Sunday meetings.

As at the end of this reporting period, the church membership was 205 adults and our Sunday attendance was approximately 340.

We are delighted to report that the church has navigated the challenges of Covid-19 well, and is meeting and operating at full strength again.

### Baptisms

Helping people to know Jesus Christ and to get baptized is a big part of the responsibility and joy of every believer and something we should all participate in fully! In the past year we have had the joy of witnessing nine people baptized.

### Life Groups

Life Groups are our midweek groups that meet in smaller number in people's homes. They are built around five core values: Friendship, 'One-anothering', Outreach, Teaching and Body Life. Life Groups are at the heart of what we do at Gateway, and we want everyone to be involved in one.

Life Groups are a great place for people to learn leadership, and a place where everyone can make a contribution. Life Groups are where the mission of the church is put into action as we serve one another and seek to bless the world around us.

Throughout the past year our Life Groups have been a vital point of connection for people as we have regathered as a community, as well as an important point of connection for people newer to the church.

Alongside meeting in people's homes, we have also maintained an online option for those choosing to meet this way.

### Serving the Community

Alongside Sunday mornings and Life Groups we would expect members of the church to be actively engaged in activities that serve the wider community, and therein we place a disproportionate emphasis on serving the poor, the lonely, the isolated and the marginalised.

The umbrella term we use for this activity is called, 'Gatehouse'. The mission statement of Gatehouse is that we exist to, 'prevent and alleviate isolation and marginalization in the BCP area and beyond.' Further details can be found on our website: <https://www.gatewaychurch.me/gatehouse>

Outlined below are some of the activities that have been undertaken to this end under the Gatehouse umbrella.

### Lifetime

Prior to lockdown Lifetime would meet twice monthly to serve adults with learning disabilities. Our aim is to offer friendship, an opportunity to worship and hear God's word in a simple and engaging way. Some of our members are able to come independently, some come with their carers and some are collected and returned home by volunteer staff, all of whom are covered by enhanced DBS checks.

Following the national lockdowns, it has been difficult to gather this community, but we have run two daytime 'celebration' events for them, including carers and family which were well attended and appreciated.

#### Oasis

Oasis is our domestic violence and abuse response team. A number of trained volunteers from Gateway Church serve the residents and children of Poole and Bournemouth domestic violence refuges. The refuge provides short-medium term emergency housing for women and children who are living in a domestic violence situation. It is thought that the rate of domestic violence increased by 25% during the national lockdowns, highlighting the seriousness of this growing trend and the importance of the church's response to it.

Having served this demographic throughout the Covid-19 pandemic, we were delighted to be able to re-establish this work in-person in the past year. It has been a delight to host monthly dinner parties for the residents of the refuge (and those who have left the refuge), put on craft activities for the children, provide friendship, signposting, lifts, and advice to various meetings and to host weekly exercise events. These events are all aimed at helping people to re-establish themselves in the community, build confidence and to demonstrate the love of Jesus in a practical way.

We have also been able to host various other events for this demographic, including days out and a Christmas party.

The relationship with the refuge management team has grown over the years and Oasis is regarded as a primary supporter of their work, creating opportunities for increased partnership working in the future. All of these activities are fully funded by the church.

We have also worked closely with the staff and parents of Bishop Aldhelms Primary School to run an initiative called 'Wishing Tree', where pupils of the school are paired with a child in refuge to purchase a Christmas gift for them.

We are thrilled that a number of residents (past and present) of the refuge were able to attend (and continue to attend) events and services at Gateway, and that we had the privilege of baptizing someone from the refuge in this reporting period.

#### Golden Generations

Following the lockdowns of the previous years, there were numerous government reports pointing to the deleterious effects of social distancing, and loneliness. The areas around our congregations are statistically among the loneliest in the UK, especially amongst the older generation.

In response to this, we began a free weekly group for older people, for refreshments, friendship and support. We are so pleased to report that this group has been regularly well attended and continues to grow in number, playing an important role in addressing loneliness and social isolation.

Some have reported this group as being their only social outlet and has become a place where the local council have from time to time, recommended people in this demographic to attend.

#### Students & 20's

Bournemouth and Poole are home to thousands of students. Bournemouth University together with the Arts University College at Bournemouth has a student roll of around 20,000. The main BU & AUCB campus is only 1.5 miles from our church building and an increasing number of students are finding their way to Gateway. During term time we have a run of student lunches with church families - a great way to meet people as well as get free food! We also encourage students to join Life Groups and become part of the church family.

In the past we have seen a real growth in numbers from this demographic which is a key part of our growth strategy. Engaging well with this community enabled us to provide food, support and other provisions during lockdown, noting that for many students, they were away from home, unable to attend physical lectures, and at risk of the emotional health challenges that have been outlined by researchers exploring the mental health effects of the Covid-19 pandemic.

It is a delight to serve this community and this will remain an important part of our service to the BCP area.

### Truth be Told

Truth be Told is an award-winning independent charity birthed at Gateway, and led by a member of our church. The premise of Truth be Told is to host and run activity and song-led toddler groups in care homes. This initiative fits well with our Gatehouse philosophy as it communicates Christian truths and draws together demographic groups who might also be most vulnerable to isolation and marginalization, such as young parents and older people in care homes.

It has been a pleasure to run Truth be Told sessions at Gateway, involving the young and the old, and to make use of the intergenerational element of Truth be Told to help rebuild social cohesion post-Covid.

### Youth

The Gateway Youth group meets every Wednesday evening and every other Sunday morning, during term time, for youth aged between 11-14 years. We create a welcoming fun space in which all youth from the area can come and join in activities and have a safe place to hang out. Our aim during these times is to see people come to know Jesus and to grow in their faith. We disciple the youth, with each youth having the opportunity to have a mentor, provide teaching from the bible, reach the local youth community through outreach events, help the community around us with social action events and generally build friendship and have fun. All youth leaders have had training and are covered by enhanced DBS checks.

Our youth community has steadily grown throughout the past year, and it has been a delight to welcome new people into this group post-Covid.

### If God Then What?

As a means of offering our community the chance to hear and ask questions about the Christian faith, we offered a series of 10 week online course (via Zoom), open to anyone, to come and hear the central claims of the Christian faith and discuss.

A number of people attended this course from across the UK, many of whom have continued to attend Gateway at least two of whom have been baptized at Gateway in the past year.

### Wishing Tree

At Christmas we were pleased to be able to work with Bishop Aldhelms Primary School to engage their pupils with our Oasis work. This was done by arranging a 'Wishing Tree' in which pupils were enabled to buy Christmas presents for the children in the domestic violence refuge, and to provide Christmas presents to be distributed via the Poole Food Bank.

### Serving other Organisations

A number of our leadership team also sit on various trustee or school governor boards in an effort to help other, similarly minded organisations to flourish, with an eye to serving those in need and bringing the truth of the gospel to light through acts of service.

### Numbers

As of 31 March 2022 there were 205 adults in membership. This number has continued a steady upward trend for the past 15 years.

## Trustees' Report

### Public Benefit Statement

The trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their power and duties.

The trustees have given due regard to public benefit when planning the charity's activities, in accordance with Sections G2 and G3 of the Charity Commission's General Guidance on Public Benefit (January 2008).

The paragraphs above set out our activities, achievements and performance during the year, which are directly related to the objects and purposes for which the charity exists. The charity achieves its principal objects and purposes through worship, teaching, counseling, group activities and pastoral support. These benefits are directly related to the aims of the charity and are fully compliant with Principles 1 and 2 of the Charity Commission Principles on Public Benefit.

The trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their power and duties.

### Financial Review

During the year ended 31 March 2022 there was a net inflow of funds of £351,320 (year ended 31 March 2021 net inflow of £105,624). In previous years the accounts have shown restricted funds separately. However, it was agreed by the Trustees at a meeting on 10 February 2021 that there are no genuine restricted funds held by the church. Instead they have only been designated for certain uses so from 2021 onwards the distinction between restricted and unrestricted funds will no longer be used.

The principal funding sources of the church are via offerings of the church members and regular attendees and the gift aid reclaimed on these gifts. Total funding during the year was £690,738 (year ended 31 March 2021 £489,820).

During 2018/19 the Baptist Union pension actuary completed its triennial valuation, confirming the financial position at 31 December 2016. The scheme continues to have a deficit but this has reduced; the liability in respect of Gateway Church was £15,500 as at 31 March 2022 (2021: £45,800).

### Reserves Policy

The trustees have examined the charity's requirements for reserves in light of the main risks to the charity. A policy whereby the funds not committed or invested in tangible fixed assets held by the charity should be between 3 and 6 months' of the expenditure has been established. Budgeted non-capital expenditure for 2022/23 is approximately £385,339 and therefore the target is £96,335 to £192,670 in general funds. The reserves are needed to meet the working capital requirements of the charity and the trustees are confident that at this level they would be able to continue the current activities of the charity in the event of a significant drop in funding. The level of free net current assets at 31 March 2022 was £418,818 (31 March 2021 £140,257).

The Trustees also meet regularly and review the financial position and will continue to monitor income and expenditure closely over the coming months.

### Statement of Trustees' Responsibilities



I have completed my examination. I confirm that no matters have come to my attention in connection with the examination giving me cause to believe:



### 1 Accounting policies

#### Summary of significant accounting policies and key accounting estimates

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### Statement of compliance

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) and the Companies Act 2006.

#### Basis of preparation

Gateway Church, Poole is a registered charity, registration number 1135330, company number 07189544, registered in the United Kingdom. The address of the charity is given in the reference and administrative details on page 1 of these financial statements. The nature of the charity's operations and principal activities are described in the Trustees' annual report.

The charity constitutes a public benefit entity as defined by FRS 102.

The financial statements are prepared on a going concern basis under the historical cost convention, modified to include certain items at fair value. The financial statements are prepared in sterling which is the functional currency of the charity and rounded to the nearest whole pound.

#### Exemption from preparing a cash flow statement

The charity has adopted Bulletin 1 published on 2 February 2016 and have therefore not included a cash flow statement in these financial statements.

#### Income and endowments

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of the income receivable can be measured reliably.

#### Donations and legacies

Donations are recognised when the charity has been notified in writing of both the amount and settlement date. In the event that a donation is subject to condition that require a level of performance by the charity before the charity is entitled to the funds, the income is deferred and not recognised until either those conditions are fully met, or the fulfilment of those conditions is wholly within the control of the charity and it is probable that these conditions will be fulfilled in the reporting period.

## Notes to the Financial Statements Year Ended 31 March 2022

### **Expenditure**

All expenditure is recognised once there is a legal or constructive obligation to that expenditure, it is probable settlement is required and the amount can be measured reliably. All costs are allocated to the applicable expenditure heading that aggregate similar costs to that category. Where costs cannot be directly attributed to particular headings they have been allocated on a basis consistent with the use of resources, with central staff costs allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use. Other support costs are allocated based on the spread of staff costs.

### **Charitable activities**

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

### **Grant provisions**

Provisions for grants are made when the intention to make a grant has been communicated to the recipient but there is uncertainty about either the timing of the grant or the amount of grant payable.

### **Governance costs**

These include the costs attributable to the charity's compliance with constitutional and statutory requirements, including audit, strategic management and trustee's meetings and reimbursed expenses.

### **Taxation**

The charity is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the charity is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

### **Tangible fixed assets**

Individual fixed assets costing £200 or more are initially recorded at cost, less any subsequent accumulated depreciation and subsequent accumulated impairment losses.

#### Depreciation and amortisation

Depreciation is provided on tangible fixed assets so as to write off the cost or valuation, less any estimated residual value, over their expected useful economic life as follows:

Asset class	Depreciation method and rate
Fixtures, fittings and equipment	25% per annum on a reducing balance basis
Cycle and work bicycles	25% per annum on a reducing balance basis
Church property and improvements	2% straight line basis

#### Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and call deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of change in value.

#### Borrowings

Interest-bearing borrowings are initially recorded at fair value, net of transaction costs.

Interest-bearing borrowings are subsequently carried at amortised cost, with the difference between the proceeds, net of transaction costs, and the amount due on redemption being recognised as a charge to the Statement of Financial Activities over the period of the relevant borrowing.

Interest expense is recognised on the basis of the effective interest method and is included in interest payable and similar charges.

Borrowings are classified as current liabilities unless the charity has an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.

#### Fund structure

Unrestricted income funds are general funds that are available for use at the trustees' discretion in furtherance of the objectives of the charity.

Designated funds are unrestricted funds set aside for specific purposes at the discretion of the trustees.

Restricted income funds are those donated for use in a particular area or for specific purposes, the use of which is restricted to that area or purpose.

#### Pensions and other post retirement obligations

The company offers a defined contribution pension scheme. Contributions are charged in the income and expenditure account as they become payable in accordance with the rules of the scheme.

Gateway Church participated in a multi-employer defined benefit pension scheme for Baptist Ministers in the UK which has been closed to new members. Deficit contributions are charged in the income and expenditure account as they become payable and Gateway Church's liability towards the scheme deficit is included in the financial statements as a provision.

### 16 Pension and other schemes

#### Defined contribution pension schemes

The charity operates a defined contribution pension scheme. The pension cost charge for the year represents contributions payable by the charity to these schemes and amounted to £23,061 (2021: £21,852).

#### Defined benefit pension schemes

The charity participates in the Baptist Union multi-employer defined benefit pension scheme. During 2017/18 the Baptist Union pension actuary completed its triennial valuation, confirming the financial position at 31 December 2016. The scheme continues to have a substantial deficit, a combination of factors, such as low interest rates, quantitative easing and low projected investment returns, have led to the rising deficit. The scheme deficit in respect of Gateway Church is £15,500 (2021: £45,800). The period for which deficit contributions need to be made has been shortened by 6.5 years from June 2035 to December 2028.

#### **18 Restricted funds**

On 10 February 2021 it was agreed at a Trustees meeting that the use of the term "restricted" should be removed from the accounts. Since the inception of the Vision Fund it was always communicated that these funds would be designated rather than restricted.

On this basis from 2021 onwards all funds previously showing as restricted have now been transferred to unrestricted funds.

#### **19 Acting as agent**

As part of the charitable mission of Gateway Church, Poole a new Church has been established in Glasgow. A new charity was established in Scotland on 28 July 2019 but prior to the charity being registered Gateway Church, Poole collected funds and paid expenses on behalf of the fledgling organisation.

These amounts have not been shown in the Statement of Financial Activities of Gateway Church, Poole. Instead, the outstanding balance owed to Glasgow Grace Church is included within creditors. As at 2021 the amount held was £nil (2020: £17,131).
