## **Beaumont Society**

### **Report of the Trustees for the Year Ended 30 June 2022**

The trustees present their report with the financial statements of the charity for the year ended 30 June 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

#### **OBJECTIVES AND ACTIVITIES**

##### **Objectives and aims**

(1) To relieve the mental and emotional stress suffered by all transgender persons, in particular but not exclusively, by providing a means of help and communication between such persons, in order to reduce the emotional stress, eliminate the sense of guilt and so aid better understanding by them and of their families and friends.

(2) To advance the education and inform lay and professional groups in all aspects of transgenderism and gender dysphoria. To gain public understanding and tolerance for the mode of behaviour and help those so affected.

The Charity's information services are targeted at both the transgender community and the general population seeking information/assistance regarding transgender issues. These services are made available without charge to the enquirer.

##### **Public benefit**

The Trustees, having regard to the guidance issued by the Charity Commission on Public Benefit, are satisfied that the work of the Beaumont Society together with its objectives and aims, meet the Charity Commission's requirements for public benefit.

The charity's information services are targeted at both the transgender community and the general population seeking information/ assistance regarding transgender issues. These services are made available without charge to the enquirer.

The charity is also active in the provision of speakers for educational training courses and conferences organised by professional bodies or lay groups whose work may involve contact with members of the transgender community.

##### **Volunteers**

In furtherance of its objectives the charity relies wholly on the work of volunteers organised on a UK regional basis to provide a service nationally to the transgender community and others.

The charity is able to provide a wide range of services without paid employees thanks to the time allocated on a voluntary basis by the Trustees and regional organisers.

The charity is dependent on sufficient Trustees/ volunteers continuing to support the work. Any inability to attract replacements for the above positions when Trustees/ volunteers step down, could adversely impact on the services provided. An Executive Committee comprising the Trustees, Magazine Editor, Executive Secretary, Membership Secretary and Regional Organisers provide considerable back up when required.

#### ACHIEVEMENT AND PERFORMANCE

##### Charitable activities

##### Achievements and performance

The Trustees recognise the importance of the commitment by both the Trustees and other volunteers and members who donate their time without remuneration, and thank all concerned for their ongoing support to further the work of the charity.

Main activities undertaken during the period from 1st July 2021 to 30th June 2022.

All meetings of the Beaumont Society - Trustees, Executive Committee and Annual General Meeting have been held online using Zoom. It is yet to be decided whether or not we return to face-to-face meetings.

The Society continues to hold informal meetings on Zoom for members every week. These are led by a member of the Executive Committee and have been well-attended throughout. Our Annual General Meeting was held on Zoom on 4th September 2021. The Society's next Annual General Meeting will also be on Zoom on Sunday 11th September at 2pm. This has been advertised in the Beaumont Magazine and on the Society's website.

The New Regional Organisers elected in the early part of 2021 have proved to be great assets to the Society. They have brought fresh ideas and energy to the Executive Committee, and have organised many informal events to support more cautious members so that they may grow in confidence in themselves and when they are out in public. They have also established a Help and Wellbeing Group where members can ask for assistance, help and advice with complete confidentiality on a number of trans-related issues and concerns.

Another member, who is also the parent of a trans woman, has created Beaumont Parents, which is a mutual support group for the parents of young adult trans people. As the membership of this group is spread throughout the United Kingdom, they also have regular Zoom meetings which are very much appreciated by those who attend. Just like trans people themselves, the parents can feel isolated and alone, but through this group they can share ideas and experiences.

Jane Hamlin (President) has been interviewed and quoted in a range of media outlets such as Daily Telegraph, GB News, Yahoo! Live, The Guardian and LBC Radio on trans-related news items.

Jennifer West resigned from her post as Executive Secretary at the end of May 2022 and Susan Garratt was elected (unopposed) as her successor.

During the year a programme of grants was launched to provide financial support to members and groups. Take-up has been slow but we will continue to bring it to members' attention via the magazine and the website.

1. The Support Assistance Grant: This is a one-off grant which may be awarded to a Trans or LGBTQ+ support group that is experiencing unexpected financial problems because of either a drop in income or an increase in costs.
2. The Support Group Start-Up Grant: This is a one-off grant which may be awarded to fund the initial costs of a newly planned transgender or LGBTQ+ support group.
3. The Transgender Event Support Grant: This one-off grant can be awarded to help fund the costs of a planned event that brings trans people together, promotes support and inclusion for trans and LGBTQ+ people and helps with our aims of supporting all gender diverse people. Applications for trans groups or individuals to enable them to participate in such an event with a float or stall would also be welcomed.
4. The Member Hardship Grant. This is a one-off grant which may be awarded to a long-standing member of the Society who is experiencing unexpected financial problems and requires a grant to see them through an emergency.

There has been some interest in these grants.

#### FINANCIAL REVIEW

##### Financial position

The attached accounts are for the twelve-month period 1st July 2021 to 30th June 2022. The Society made a surplus of just over £9000 in the year. As in the previous year this was a combination of donations, gift-aided tax relief and continued reduction in expenses as a result of Covid-19 restrictions limiting activities.

The charity made a surplus of £9240 during the year (2021 - surplus of £10933). This brings the total available reserves carried forward to £96269, compared with last years £87029.

##### Reserves policy

The Society currently has adequate reserves to meet foreseeable demand. The available reserves are enough to cover any financial obligations.

#### **FINANCIAL REVIEW**

##### **Going concern**

The trustees have assessed a period of 12 months from the date of approval of the financial statements and consider that no material uncertainties exist that cast significant doubt about the ability of the charity to continue as a going concern. Thus the trustees adopt the going concern basis of accounting in preparing the financial statements.

#### **FUTURE PLANS**

The Charity's plans for the future are to continue to address the Aims and Vision set out in our Constitution:  
by developing the content on our website to increase awareness and understanding of transgender-related issues both for members and the wider public;  
by increasing our own awareness of the needs of young trans adults, and the parents and families of young trans adults, and  
by researching issues that are relevant to trans people.

#### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

##### **Governing document**

The Beaumont Society (the charity) is an unincorporated association governed by a constitution adopted on 14th March 2010. The most recent version was approved on 10th August 2019. It currently has a membership of about 840(2020 - 806).

##### **Recruitment and appointment of new trustees**

New Trustees may initially be appointed by the existing Trustees but must then stand for election at the next AGM. Once appointment is confirmed by the membership one third of the Trustees by rotation must stand for re-election each year.

##### **Decision making**

All decisions are made by the committee, either the executive committee or, if the matter is such that it requires a decision by the trustees, then by the trustees. All decisions would require a majority vote to be passed and there is no provision for any trustee or member of the executive committee to make a decision on their own.

As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').



#### 1. ACCOUNTING POLICIES

##### **Basis of preparing the financial statements**

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

##### **Going Concern**

The directors have assessed a period of 12 months from the date of approval of the financial statements and consider that no material uncertainties exist that cast significant doubt about the ability of the company to continue as a going concern. Thus the directors adopt the going concern basis of accounting in preparing the financial statements.

##### **Income**

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

##### **Expenditure**

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

##### **Taxation**

The charity is exempt from tax on its charitable activities.

##### **Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

##### **Provisions**

Provisions are recognised when the entity has an obligation at the reporting date as a result of a past event; it is probable that the entity will be required to transfer economic benefits in settlement and the amount of the obligation can be estimated reliably. Provisions are recognised as a liability in the statement of financial position and the amount of the provision as an expense.

Provisions are initially measured at the best estimate of the amount required to settle the obligation at the reporting date and subsequently reviewed at each reporting date and adjusted to reflect the current best estimate of the amount that would be required to settle the obligation. Any adjustments to the amounts previously recognised are recognised in profit or loss unless the provision was originally recognised as part of the cost of an asset. When a provision is measured at the present value of the amount expected to be required to settle the obligation, the unwinding of the discount is recognised in finance costs in profit or loss in the period it arises.

## Beaumont Society

### Report of the Trustees for the Year Ended 30 June 2021

The trustees present their report with the financial statements of the charity for the year ended 30 June 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

#### **OBJECTIVES AND ACTIVITIES**

##### **Objectives and aims**

(1) To relieve the mental and emotional stress suffered by all transgender persons, in particular but not exclusively, by providing a means of help and communication between such persons, in order to reduce the emotional stress, eliminate the sense of guilt and so aid better understanding by them and of their families and friends.

(2) To advance the education and inform lay and professional groups in all aspects of transgenderism and gender dysphoria. To gain public understanding and tolerance for the mode of behaviour and help those so affected.

The Charity's information services are targeted at both the transgender community and the general population seeking information/assistance regarding transgender issues. These services are made available without charge to the enquirer.

##### **Public benefit**

The Trustees, having regard to the guidance issued by the Charity Commission on Public Benefit, are satisfied that the work of the Beaumont Society together with its objectives and aims, meet the Charity Commission's requirements for public benefit.

The charity's information services are targeted at both the transgender community and the general population seeking information/ assistance regarding transgender issues. These services are made available without charge to the enquirer.

The charity is also active in the provision of speakers for educational training courses and conferences organised by professional bodies or lay groups whose work may involve contact with members of the transgender community.

##### **Volunteers**

In furtherance of its objectives the charity relies wholly on the work of volunteers organised on a UK regional basis to provide a service nationally to the transgender community and others.

The charity is able to provide a wide range of services without paid employees thanks to the time allocated on a voluntary basis by the Trustees and regional organisers.

The charity is dependent on sufficient Trustees/ volunteers continuing to support the work. Any inability to attract replacements for the above positions when Trustees/ volunteers step down, could adversely impact on the services provided. An Executive Committee comprising the Trustees, Magazine Editor, Executive Secretary, Membership Secretary and Regional Organisers provide considerable back up when required.

The Trustees recognise the importance of the commitment by both the Trustees and other volunteers and members who donate their time without remuneration and thank all concerned for their ongoing support to further the work of the charity.

#### ACHIEVEMENT AND PERFORMANCE

##### Charitable activities

The Society held its first online Executive Committee (using Zoom) on the 6th November 2020. Since then there have been regular online meetings of both Executive Committee and Trustees. With London Friend still closed, we intend to conduct Trustee and Committee business in this way until further notice. It is hoped to return to face-to-face meetings as soon as it is feasible.

A Zoom licence has been obtained enabling the Society to hold meetings for members every week. These are led by a member of the Executive Committee and have been well-attended throughout.

Due to the Covid pandemic the Society was unable to conduct an AGM in 2020. It is the intention to hold one via a video conference on 4th September this year. This has been advertised in the Beaumont Magazine.

Previously, the Magazine Editor position was not included as a member of the Executive Committee. It was decided to rectify this and it was voted upon at the January 14th 2021 EC meeting and passed unanimously. The constitution has been duly amended. This will be ratified at the AGM in September.

In the light of the Society's healthy financial status it has been agreed to earmark funds on a series of grants as shown below:

1. The Support Assistance Grant: This is a one-off grant which may be awarded to a Trans or LGBTQ+ support group that is experiencing unexpected financial problems because of either a drop in income or an increase in costs.
2. The Support Group Start-Up Grant: This is a one-off grant which may be awarded to fund the initial costs of a newly planned transgender or LGBTQ+ support group.
3. The Transgender Event Support Grant: This one-off grant can be awarded to help fund the costs of a planned event that brings trans people together, promotes support and inclusion for trans and LGBTQ+ people and helps with our aims of supporting all gender diverse people. Applications for trans groups or individuals to enable them to participate in such an event with a float or stall would also be welcomed.
4. The Member Hardship Grant. This is a one-off grant which may be awarded to a long-standing member of the Society who is experiencing unexpected financial problems and requires a grant to see them through an emergency.

Jane (President) represented the Society, along with people from Stonewall, Mermaids and GIRES, in a House of Commons Women & Equalities Select Committee consultation on the 17th March 2021. This was regarding the Gender Recognition Act.

The Society has recruited three new Regional organisers. Karen Cobham (Scotland), Lynne Jones (Central) and Andrea Brookes (South).

#### FINANCIAL REVIEW

##### Financial position

The attached accounts are for the twelve-month period 1st July 2020 to 30th June 2021. The Society made a surplus of almost £11,000 in the year. This was due, in large part, to recovery of tax on Gift-Aided subscriptions and donations, amounting to £7,500, and also to reduced expenses as a result of Covid-19 restrictions limiting activities.

The charity made a surplus of £10933 during the year (2020 - surplus of £5923).

##### Reserves policy

The Society currently has adequate reserves to meet foreseeable demand. The available reserves are enough to cover any financial obligations.

##### Going concern

The trustees have assessed a period of 12 months from the date of approval of the financial statements and consider that no material uncertainties exist that cast significant doubt about the ability of the charity to continue as a going concern. Thus the trustees adopt the going concern basis of accounting in preparing the financial statements.

#### **FUTURE PLANS**

The Charity's plans for the future are to continue to address the Aims and Vision set out in our Constitution:  
by developing the content on our website to increase awareness and understanding of transgender-related issues both for members and the wider public;  
by increasing our own awareness of the needs of young trans adults, and the parents and families of young trans adults, and  
by researching issues that are relevant to trans people.

#### **Covid-19**

For the charity's own activities the effect of Covid has been limited, stopping us from holding our regular quarterly trustees' and executive committee meetings. The annual meeting is normally held as part of a weekend event in Harrogate organised by a past-president of the charity but not a Beaumont Society event. That, like most other planned events across the whole country, was postponed, then cancelled. Support groups around the country all stopped meeting - these events are often organised and attended by regional officers who are all members of the exec group although they are not, formally, Beaumont Society meetings.

#### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

##### **Governing document**

The Beaumont Society (the charity) is an unincorporated association governed by a constitution adopted on 14th March 2010. The most recent version was approved on 10th August 2019. It currently has a membership of about 806 (2019 - 729).

##### **Recruitment and appointment of new trustees**

New Trustees may initially be appointed by the existing Trustees but must then stand for election at the next AGM. Once appointment is confirmed by the membership one third of the Trustees by rotation must stand for re-election each year.

##### **Decision making**

All decisions are made by the committee, either the executive committee or, if the matter is such that it requires a decision by the trustees, then by the trustees. All decisions would require a majority vote to be passed and there is no provision for any trustee or member of the executive committee to make a decision on his or her own.

As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').



#### 1. ACCOUNTING POLICIES

##### **Basis of preparing the financial statements**

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

##### **Going Concern**

The directors have assessed a period of 12 months from the date of approval of the financial statements and consider that no material uncertainties exist that cast significant doubt about the ability of the company to continue as a going concern. Thus the directors adopt the going concern basis of accounting in preparing the financial statements.

##### **Income**

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

##### **Expenditure**

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

##### **Taxation**

The charity is exempt from tax on its charitable activities.

##### **Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

##### **Provisions**

Provisions are recognised when the entity has an obligation at the reporting date as a result of a past event; it is probable that the entity will be required to transfer economic benefits in settlement and the amount of the obligation can be estimated reliably. Provisions are recognised as a liability in the statement of financial position and the amount of the provision as an expense.

Provisions are initially measured at the best estimate of the amount required to settle the obligation at the reporting date and subsequently reviewed at each reporting date and adjusted to reflect the current best estimate of the amount that would be required to settle the obligation. Any adjustments to the amounts previously recognised are recognised in profit or loss unless the provision was originally recognised as part of the cost of an asset. When a provision is measured at the present value of the amount expected to be required to settle the obligation, the unwinding of the discount is recognised in finance costs in profit or loss in the period it arises.
