C) TO PROVIDE OR ASSIST IN THE PROVISION OF FACILITIES (IN THE AREA OF BENEFIT) IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE INFIRMITY OR DISABILITY, FINANCIAL HARDSHIP OR SOCIAL CIRCUMSTANCES WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE. THE "AREA OF BENEFIT" WILL BE SEAFIELD, GOLDEN GROVE AND HAM WALK AREAS IN JAMAICA OR SUCH OTHER PLACES OR COUNTRIES AS THE GROUP DETERMINES FROM TIME TO TIME.

Activities: The primary area of benefit will be Seafield, Golden Grove & Ham Walk areas in Jamaica. Main aims are A) Advance the broad education of pupils. B) Promote good health by supporting primary healthcare activities. C) Assist in the provision of facilities for recreation with the object of improving the conditions of life of the residents in the area of benefit.
