The trustees present their report and accounts for the year ended 31 March 2025.

Structure, Governance and Management

Norwood Community Group Services Limited is a charitable company limited by guarantee, with no share capital, incorporated on 11 March 2010 and registered as a charity on 14 June 2010. The company was established under a Memorandum of Association which established the objects and powers of the charitable company and is governed under its Articles of Association. In the event of winding up, the members of the company are liable to subscribe for £10 each to satisfy their guarantee to the company.

The trustees are known as members of the Management Committee and meet on a regular basis to undertake its monitoring and strategic role. The day to day management of the charity is the responsibility of the director, who attends all management committee meetings and reports on all key management and strategic matters.

Objectives and Activities

The principal objectives and activities are to further benefit the residents of Lambeth and surrounding areas in a common effort to advance education and to provide facilities in the interest of social welfare for recreation, leisure time occupation with the object of improving the conditions of life for the residents.

During the year, the following activities were undertaken which are in line with the Charity's objectives as outlined in our Articles of Association.

- Fit 4 Life-Karate Washinkai is delivered Monday's at The Old Library Hub, 14-16 Knights Hill, West Norwood between 6.00pm and 7.30pm and is open to all members of the community regardless of age, this activity is attended regularly by the local community.
- Fit 4 Life-Kickboxercise is delivered every Tuesday at the Elmgreen School Elmcourt Road, West Norwood between 6pm and 7.30pm and is open to young people/parents ages 7 - 19.
- Our theme this year has been to focus on mentoring young people , which have included a Mixed Martial Arts Summer project, Mentoring programs and recreational activities throughout the year. Promoting social awareness and responsibility to its community members.
- The Early Intervention Services (EIPS) objective is to promote partnership work between local groups. Norwood Community Group Services of a consortium with Rathbone High Trees Community Development Trust Fulham Kiks, 4 All and Jazz Academy, Upper Norwood Library Hub and the Great North wood Collective This will allow us to utilise each others resources and work jointly to reach our objectives.

- We have been attracting fans of Norwood Community Group Services through NCGS website, Social networking sites such as facebook, TikTok, LinkedIn, WhatsApp and Twitter these outlets allow us to get our message across and build our audience locally as well as nationally.

Our constant endeavour to raise awareness of the services provided by the Charity within the community, has lead to an increased number of people utilising the services we provide.

Achievements and Performance

During the academic year, NCGS were able to accredit 8 young people through our kickboxercise class with Assessment & Qualification Alliance (AQA) certification 'Introduction to Kickboxing'. We also graded 3 young people through the British Traditional Karate Association (BTKA) Karate Washinkai.

- NCGS and its consortium partners succesfully received a grant in January 2024 from the Propel Fund for Mentoring services to help tackle local issue amongst the youth.
- Our user base has risen in the 2024, we have had an increase in young people and parents attending our classes.

NCGS are affiliated with AQA and the BTKA both accredited outcomes, which enables us to reward our users with something tangibly to remind them of their experiences.

The recognition and achievements of the above has enhanced the Charity's status from the perspective of the present sponsors and hopefully for future sponsors.

Reserves Policy



Independent examiner's report to the trustees of Norwood Community Group Services Ltd

1 Accounting policies

Basis of preparation

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts.

The accounts have been prepared in accordance with the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and with the Charities Act 2011.

Funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity. These funds are recognised when receivable. Grants are recognised in full in the statement of financial activities in the year in which they are receivable, unless they are for a future period, in which case they are deferred and disclosed as deferred income within creditors due within one year.

Income recognition

All income is recognised in the Statement of Financial Activities when the charity is entitled to the income, there is sufficient certainty of receipt and the amount of income can be measured reliably.

Expenditure recognition

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured or estimated reliably.

Debtors

Short term debtors are measured at transaction price (which is usually the invoice price), less any impairment losses for bad and doubtful debts. Loans and other financial assets are initially recognised at transaction price including any transaction costs and subsequently measured at amortised cost determined using the effective interest method, less any impairment losses for bad and doubtful debts.

Creditors

Short term creditors are measured at transaction price (which is usually the invoice price). Loans and other financial liabilities are initially recognised at transaction price net of any transaction costs and subsequently measured at amortised cost determined using the effective interest method.
