**Objects:** TO ADVANCE THE EDUCATION AND TRAINING OF YOUNG PERSONS UP TO THE AGE OF 20 LIVING OR BEING EDUCATED IN A TEN MILE RADIUS OF THE QUAY AT WELLS-NEXT-THE SEA IN MARITIME AND WATER ACTIVITIES AND PROVIDING MARITIME QUALIFICATIONS TO ENHANCE THEIR EDUCATION, PERSONAL AND PROFESSIONAL DEVELOPMENT. BENEFICIARIES MAY ALSO INCLUDE PERSONS UP TO THE AGE OF 25 AND / OR LIVING UP TO 20 MILES FROM THE QUAY IF TRUSTEES CONSIDER THAT THERE IS SUFFICIENT PUBLIC BENEFIT AND CONNECTION TO THE WELLS AREA

**Activities:** To advance public knowledge of the heritage harbour through educational awareness initiatives, provide developmental opportunities for the harbour's stakeholders and promote the local marine environment.
