The Trustees express gratitude to donors, volunteers, and partners whose contributions were instrumental in achieving these results.

**Financial Review**

The charity's total income for the year amounted to **£31,180**, sourced entirely from **donations**.

**Expenditure:**

**Notes to the Accounts****1. Accounting Basis:**

These accounts have been prepared on a receipts and payments basis, as permitted for charities with income under £250,000, in accordance with the Charities Act 2011.

**2. Income:**

- The charity's income of £31,180 was derived entirely from donations. No income was eligible for Gift Aid during the reporting period.

**3. Expenditure:**

- Relief Aid Distribution (£5,077): Funds used to provide financial support, food, and medical aid to beneficiaries.
- Educational Grants (£3,000): Allocated to provide school supplies and scholarships to children.
- Administrative Costs (£1,580): Included costs associated with governance, technology, and operational expenses.

**4. Reserves:**

The charity holds unrestricted reserves of £21,523 to ensure operational sustainability and allow for flexibility in responding to future needs.

**5. Trustee Remuneration and Expenses:**

No Trustees received any remuneration or reimbursement of expenses during the reporting period.

Total expenditure was **£9657**, allocated as follows:
  - **Relief Aid Distribution:** £5077
  - **Educational Grants:** £3,000
  - **Administrative Costs:** £1,580

**3. Financial Position:**

The charity's financial position as at 31 December 2023 showed reserves of **£21,523**, which ensures sustainability and can support future operational costs.
