There was a 44% decrease in both income and grantmaking compared with the previous year. There was a deficit for the year which was funded from reserves held.

The trustees do not seek to maintain reserves, other than to ensure that they can continue the activities of the charity. Reserves at the year end were £3,096 (2024 - £5,410).

FUTURE PLANS

The charity plans to continue its activities for the foreseeable future subject to satisfactory income.
