2. Structure, Governance and Management

Governing Document

The charity is governed by its constitution and operates in accordance with the Charities Act 2011.

Governance Structure

The charity is overseen by a Board of Trustees, chaired by the Senior Pastor. The Trustees are responsible for strategic direction, financial oversight, compliance, and safeguarding the charity's assets.

Operational delivery is supported by:

- A Pastoral Council
- Administrative officers
- Specialist committees where required

Branch churches operate with limited autonomy and are required to submit **monthly financial and activity reports** to the central office.

Trustee Appointment and Induction

Trustees are appointed in accordance with the governing document. New Trustees receive induction and ongoing guidance to ensure they understand their legal responsibilities and the charity's operations.

3. Objectives and Public Benefit

Charitable Objects

The charity's principal object is the **advancement of the Christian faith** for the benefit of the public.

Public Benefit Statement

The Trustees confirm that they have had due regard to the Charity Commission's guidance on public benefit when planning and reviewing the charity's activities.

The charity provides inclusive religious, educational, welfare, and community-based activities that are open to the general public regardless of religious background. These activities promote spiritual, Health wellbeing, education, social cohesion, and support for vulnerable individuals and families.

4. Activities and Achievements

During the year ended 31 March 2025, the charity carried out the following principal activities in furtherance of its charitable objectives:

Evangelism and Religious Activities

- Public worship services and Christian celebrations including Easter, Christmas, and New Year services
- Street evangelism and gospel outreach in public spaces
- House fellowship meetings and pastoral care programmes

Community Support and Welfare

- Food distribution and support through food banks
- Prison and hospital visitations
- Legal counselling and welfare advice
- Donations to care homes, children's funds, and community initiatives

Health, Social Awareness and Wellbeing

- Public health awareness forums and workshops
- Educational seminars addressing youth violence, substance misuse, and unplanned pregnancies
- Support for government health and wellbeing initiatives through the Women Foundation and Men of Valour programmes

Education and Training

- Continued operation of schools
- Leadership, Ministers and church worker training
- Training to empower and align with innovation, digital and technology
- Theological and ministerial training programmes
- Establishment of additional house fellowship centres

Media and Digital Outreach

- Radio and online prayer meetings with over 2,000 live participants
- Distribution of recorded teaching and prayer sessions to wider audiences

Youth, Family and Community Engagement

- Youth clubs with a Christian ethos
- Pastoral services including baptisms, marriages, and funerals
- Support programmes for senior citizens, parents, toddlers, and individuals with special needs
- Organisation of community events such as the, Musical Concert Festivals, Watford Community Family Fun Day to promote unity, social cohesion and togetherness.

5. Financial Review

Income and Expenditure

The charity's income is derived primarily from tithes, offerings, voluntary donations, local council funding, grants and income from events. Expenditure was applied in furtherance of the charity's objectives.

Financial Position

The Trustees have managed resources prudently throughout the year. Funds are currently being conserved towards the acquisition of a central Church Centre Complex, which will provide worship, administration, training, and community facilities and reduce long-term venue hire costs.

6. Reserves Policy

The Trustees aim to maintain free reserves equivalent to approximately 12 months of operating expenditure. This policy is intended to ensure financial resilience and the continuation of charitable activities in the event of unforeseen circumstances.

7. Risk Management

The Trustees regularly review risks that could affect the charity's operations. Key risks, particularly those associated with decentralized branch activities, are managed through:

- Clear policies and procedures
- Volunteer training and supervision
- Regular reporting and financial controls
- Periodic risk assessments
- Access to professional legal and financial advice when required

8. Plans for Future Periods

The Trustees have identified the following priorities for future development:

- Appointment of additional Trustees and establishment of a Management Committee
- Expansion of community outreach and vocational training programmes
- Development of youth recreational centres
- Increased investment in radio and television media outreach
- Enhanced outreach to underserved groups including prisoners, widows, and orphans
- Organisation of large-scale evangelistic crusades
- Acquisition of a UK headquarters and prayer arena
- Establishment of additional schools and support for international missions
- Partnerships with other charitable organisations in the UK and overseas

9. Volunteers

The charity relies heavily on the support of volunteers who give their time and skills across all programs. The Trustees express their sincere gratitude for the dedication and commitment of all volunteers.

10. Remuneration Policy


Trustees serve on a voluntary basis and receive no remuneration or benefits. Pastoral remuneration, where applicable, is determined in accordance with the charity's policies and approved by the Trustees.
