Objects: THE CHARITY'S OBJECTS ("THE OBJECTS"), BEING PRIMARILY UNDERTAKEN IN UGANDA BUT NOT RESTRICTED TO THIS AREA ARE: I. THE RELIEF OF SICKNESS AND THE PROMOTION OF GOOD HEALTH II. THE ADVANCEMENT OF EDUCATION AND SKILLS TRAINING BY ENGAGING IN FORMAL SCHOOLING AND VOCATIONAL TRAINING III. THE RELIEF OF POVERTY AND FINANCIAL HARDSHIP BY PROVIDING OR ASSISTING IN THE PROVISION OF SUPPORT DESIGNED TO ENABLE INDIVIDUALS TO GENERATE A SUSTAINABLE INCOME AND BE SELF-SUFFICIENT IV. THE PROMOTION OF EQUALITY OF OPPORTUNITY BETWEEN MEN AND WOMEN, IN PARTICULAR BUT NOT EXCLUSIVELY BY: A) PROVIDING INFORMATION AND RAISING AWARENESS OF THE ISSUES FACING WOMEN IN UGANDA B) ENCOURAGING MEMBERS OF THE KARAMOJONG COMMUNITY IN UGANDA TO ALLOW THE PARTICIPATION OF WOMEN IN DECISION MAKING PROCESSES C) WORKING WITH BOTH MEN AND WOMEN IN CARRYING OUT PROGRAMS ON THE PREVENTION OF DOMESTIC VIOLENCE AGAINST WOMEN AND GIRLS D) EMPOWERING WOMEN AND GIRLS TO PLAY A GREATER ROLE WITH RESPECT TO PARTICIPATING IN THEIR COMMUNITY AND ITS DEVELOPMENT

Activities: To meet the needs of Karamojong children and their community in Uganda. To meet those needs mainly by support to a primary school in the provision of text books and other supplies and by providing buildings and equipment at the school. To provide educational bursaries. To assist the school and other areas of the community with nutritional meals and other forms of support.
