**Objects:** A) TO ADVANCE THE CHRISTIAN RELIGION BY SERVING THE PUBLIC WORKING IN, FREQUENTING OR VISITING THE TOWN CENTRE OF BEDFORD, AND BY THE PROVISION OF PASTORAL CARE, INCLUDING BUT NOT LIMITED TO THE FORMATION OF THE STREET ANGELS PROGRAMME.(B) TO PROMOTE THE MENTAL AND SPIRITUAL WELLBEING OF THE INHABITANTS OF BEDFORD, BY THE PROVISION OF ADVICE AND SUPPORT.(C) TO SUPPORT, CARE AND TREAT PERSONS IN NEED WHO ARE HOMELESS AND SUFFERING FROM THE EFFECTS OF POVERTY, SICKNESS, DISABILITY, OLD AGE, ALCOHOLISM, DRUG ADDICTION, OFFENDING BEHAVIOUR, OR ANY OTHER MENTAL OR PHYSICAL INFIRMITY, AS AN EXPRESSION OF CHRISTIAN FAITH.

**Activities:** To train and organise one or more teams of volunteers (known as Street Angels) drawn from local Christian churches to patrol the streets of Bedford town centre and to give support to those that are vulnerable in the night-time economy.
