Summary of the purposes of the charity as set out in its governing document	Para 1.17	<p>In association with Ascension Trust, Worcester Street Pastors' objectives are:</p> <p>To advance education in accordance with Christian principles by such means as the management team may consider appropriate in Worcester and in such other parts of the United Kingdom or the world as the management team may from time to time think fit and to fulfil such other purposes which are exclusively charitable according to the law of England and Wales and are connected with the charitable work of the Charity.</p> <p>To relieve sickness and financial hardship and to promote and preserve good health by the provision of funds goods or services of any kind including through the provision of counselling and support in Worcester and in such other parts of the United Kingdom or the world as the management team may from time to time think fit.</p> <p>To advance the Christian Faith in accordance with the Licence Agreement executed with Ascension Trust and the Core Values and Mission Statement, in Worcester and in such other parts of the United Kingdom or the world as the management team may from time to time think fit particularly but not exclusively by means of caring, listening and helping people on the streets and at various venues day and night.</p>
Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	<p>A street pastor is someone from the Christian community who is willing to care, listen and help particularly young people who have found themselves disenfranchised and/or marginalised from society, and who are willing to engage people where they are, in</p>

terms of their thinking (perspective of life) and location (where they hang out - be it on the streets, in pubs and clubs or at parties).

A street pastor is there to get to know people in the community and to build relationships in order to find out their needs and what can be done to help. Street pastors must gain the credibility of the community, so that the community knows that the church has come to them.

A street pastor's main role is to make themselves available to care, listen, support and help vulnerable people, especially young individuals, to move into positive endeavours. Street pastors come from right across the Christian community, and can be anyone who:

- is 18 years old or over (no upper age limit)
- has been committed to a Christian fellowship for at least a year
- has obtained a supportive reference from their senior church leader
- has undergone a DBS check
- has successfully attended street pastor training.

Street pastor teams are committed to deeper day-to-day working partnerships with relevant statutory agencies and voluntary organisations.

The aim and intention is that Worcester Street Pastor teams (usually of 4, occasionally 3) will patrol Worcester city centre's streets each Saturday night/Sunday morning from around 10pm until up to 4am, depending upon how many people are around & what's happening. Their strategic role is to care, listen and help; giving assistance to people in need; seeking to prevent victimisation; bringing calm to tense situations; comforting and supporting those in difficulty or distress - often due directly or indirectly to excess alcohol consumption by themselves or others; and seeking to support/assist the statutory agencies and other services as best they reasonably can.

The continuing Covid-19 crisis caused major disruption to patrol operations. Legal restrictions and Central Government guidance meant teams at times were unable to operate for extended periods, with venues closed and city centre streets virtually deserted. Even when restrictions started to ease it was necessary to consider the safety of street pastor volunteers, some being vulnerable with underlying health conditions.

Contribution made by volunteers	Para 1.38	<p>Worcester Street Pastors is entirely reliant upon the contributions of volunteers as management team members, operational street pastors and prayer pastors. Operational street pastors give not only their time freely for Saturday night/Sunday morning patrols and training but also contribute financially towards the organisation's costs.</p> <p>Further, Worcester Street Pastors' work could not continue without the sacrificial commitment of many who support in prayer, plus the generous financial support of some local churches and individuals.</p>

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	<p>We entered 2021 still unable to resume patrols, but this became possible in mid-May. Fortunately we had continued to maintain/develop operational readiness, which enabled teams to be back into business without undue difficulty.</p> <p>Whilst the aim & intention is for street pastor teams to be out every Saturday night through the year, due primarily to the restrictions it was only possible to cover 52% of the 52 weekends.</p> <p>A total of 654 people were helped on the streets in some way; 456 bottles/glasses/fragments were safely cleared away; 18 incidents of anti-social behaviour were attended; 10 people were signposted to other organisations for longer-term advice/support; 111 pairs of flip-flops were given out to people in need of feet protection; and 122 "rough sleepers" were checked upon.</p>

		<p>In 2019, the management team adopted development goals/priorities:</p> <ul style="list-style-type: none"> - consolidate present operations through a 30% increase in the street pastor team within 12 months - expand operations into a second night through a 100% increase in the street pastor team within 2 years - initiate discussions with other agencies/ organisations within 12 months upon partnering in a safe place initiative - explore and implement ways to strengthen prayer support. <p>The Covid-19 crisis prevented progress upon expansion and development of patrolling operations, but recruitment and training have now resumed and are progressing. Conversations are continuing on the prospect of establishing some form of partnered safe place, primarily within Safer Worcester Partnership as part of Project X proposals; funds have been set aside in reserve towards our contribution.</p> <p>All continue to be greatly encouraged by Sue's faithful support in overseeing and delivering prayer support, ably assisted by Lydia; their regular Saturday night attendance with the teams is greatly valued and appreciated. Sue also ensures WSP's inclusion in her wider engagements with churches and prayer activities/events.</p>

Review of the charity's financial position at the end of the period	Para 1.21	We were fortunate/blessed to close the year in a strong financial position, with balances of £38,948. We continue to benefit from grant funding by the Police & Crime Commissioner which enables retention of Jerry Reakes-Williams as part-time paid operations co-ordinator. We must also acknowledge Jane Edwards' hard work & faithful commitment as part-time paid promotions co-ordinator, adding very substantially to our funds through many - mostly successful - applications to a range of funding charities.


