Objects: 1 TO ADVANCE THE EDUCATION OF PUPILS WITH SPECIAL EDUCATIONAL NEEDS (SEN) AND/OR DISABILITIES IN IDENTIFIED AREAS OF INDIA AND OTHER COUNTRIES AROUND THE WORLD BY PROVIDING AND ASSISTING LOCAL STAFF WITH THE PROVISION OF TRAINING, SPECIALIST PROFESSIONAL HELP, EQUIPMENT AND DEVELOPMENT IN COMMUNICATION.2 TO ADVANCE THE EDUCATION OF PUPILS WITH SPECIAL EDUCATIONAL NEEDS IN MAINSTREAM AND SEN SCHOOLS IN INDIA AND THE UK BY WORKING WITH, AND SUPPORTING CHARITIES, ORGANISATIONS OR INDIVIDUALS IN PROVIDING SUCH EDUCATION AND BY FACILITATING AN EXCHANGE PROGRAMME WHICH INCREASES KNOWLEDGE IN THE AREA OF SEN AND ALSO BETTER EQUIP PEOPLE WORKING WITH PUPILS. 3 TO ADVANCE EDUCATION FOR CHILDREN AND ADULTS IN INDIA OR OTHER COUNTRIES BY SUCH MEANS AS THE TRUSTEES THINK FIT, IN PARTICULAR BUT NOT EXCLUSIVELY BY PROVIDING ADVICE, RESOURCES AND FACILITIES WHICH HELP STUDENTS, TEACHERS OR OTHER PROFESSIONALS TO PROVIDE EDUCATION PARTICULARLY FOR THE BENEFIT OF THOSE WITH SPECIAL EDUCATIONAL NEEDS. 4 THE PROMOTION OF SOCIAL INCLUSION FOR PARENTS AND THEIR CHILDREN WHO ARE SOCIALLY EXCLUDED FROM SOCIETY OR PARTS OF SOCIETY BECAUSE THEY ARE FROM ETHNIC MINORITIES AND/OR BECAUSE THEY HAVE BEEN EXCLUDED AND DISCRIMINATED AGAINST BASED ON THEIR INCOME, STATUS OR HAVING A CHILD WITH DISABILITIES IN PARTICULAR BUT NOT EXCLUSIVELY BY;A PROVIDING OR FACILITATING WORKSHOPS, TRAINING, FORUMS AND PRACTICAL ADVICE SURGERIES FOR PUBLIC BENEFIT TO REACH OUT TO COMMUNITIES IN DIFFERENT LANGUAGES. B PROVIDING EDUCATION AND INFORMATION TO SUPPORT AND ENABLE PARENTS AND STAFF TO MAXIMISE EDUCATIONAL OPPORTUNITIES FOR THE CHILDREN IN THEIR INSTITUTION, SCHOOL OR CHARITY.C RAISING PUBLIC AWARENESS OF THE ISSUES AFFECTING PARENTS WITH SPECIAL NEEDS CHILDREN AND WAYS TO OVERCOME THEM BOTH GENERALLY AND IN RELATION TO THE SOCIAL EXCLUSION.D PROVIDING RECREATIONAL FACILITIES AND OPPORTUNITIES FOR THE CHILDREN WITH SEN AND DISABILITIES WORKING TOGETHER WITH CHILDREN FROM MAINSTREAM AND OTHER LOCAL EDUCATIONAL INSTITUTIONS. 5 THE PREVENTION OR RELIEF OF POVERTY IN INDIA AND THIRD WORLD COUNTRIES BY PROVIDING ITEMS AND SERVICES TO INDIVIDUALS IN NEED AND/OR CHARITIES, OR OTHER ORGANISATIONS WORKING TO PREVENT OR RELIEVE POVERTY.
