Objects: TO ADVANCE EDUCATION IN ACCORDANCE WITH CHRISTIAN PRINCIPLES BY SUCH MEANS AS THE MANAGEMENT COMMITTEE MAY CONSIDER APPROPRIATE IN GRAVESHAM AND IN SUCH OTHER PARTS OF THE UNITED KINGDOM OR THE WORLD AS THE MANAGEMENT COMMITTEE MAY FROM TIME TO TIME THINK FIT AND TO FULFILL SUCH OTHER PURPOSES WHICH ARE EXCLUSIVELY CHARITABLE ACCORDING TO THE LAW OF ENGLAND AND WALES AND ARE CONNECTED WITH THE CHARITABLE WORK OF THE CHARITY. WHERE THE CHARITY CARRIES OUT SCHOOL PASTORING WORK IT MAY BE REFERRED TO AS GRAVESHAM SCHOOL PASTORS. HOWEVER, THE WORK OF GRAVESHAM SCHOOL PASTORS IS MERELY PART OF THE ACTIVITIES OF GRAVESHAM STREET PASTORS AND THE LEGAL NAME OF THE CHARITY REMAINS GRAVESHAM STREET PASTORS. TO RELIEVE SICKNESS AND FINANCIAL HARDSHIP AND UNDER-ACHIEVEMENT IN EDUCATION AND TO PROMOTE AND PRESERVE GOOD HEALTH BY THE PROVISION OF FUNDS GOODS OR SERVICES OF ANY KIND INCLUDING THROUGH THE PROVISION OF COUNSELLING, MENTORING AND SUPPORT IN GRAVESHAM AND IN SUCH OTHER PARTS OF THE UNITED KINGDOM OR THE WORLD AS THE MANAGEMENT COMMITTEE MAY FROM TIME TO TIME THINK FIT TO ADVANCE THE CHRISTIAN FAITH IN ACCORDANCE WITH THE LICENCE AGREEMENT EXECUTED WITH ASCENSION TRUST AND THE CORE VALUES AND MISSION STATEMENT APPEARING IN THE SCHEDULE HERETO IN GRAVESHAM AND IN SUCH OTHER PARTS OF THE UNITED KINGDOM OR THE WORLD AS THE MANAGEMENT COMMITTEE MAY FROM TIME TO TIME THINK FIT PARTICULARLY BUT NOT EXCLUSIVELY BY MEANS OF CARING, LISTENING AND HELPING; (A) PEOPLE ON THE STREETS AND AT VARIOUS VENUES DAY AND NIGHT AND (B) PUPILS AND STUDENTS AT SCHOOLS AND COLLEGES.

Activities: STREET PASTORS: THEIR VOLUNTEERS PROVIDE SUPPORT, A LISTENING EAR AND PRACTICAL HELP, TO THOSE OUT ON THE STREETS OF GRAVESHAM AT NIGHT, HELPING TO KEEP THE PEACE AND PROTECT THE VULNERABLE. SCHOOL PASTORS: WORKING WITH LOCAL SCHOOLS/COLLEGES THEY PROVIDE SIMILAR SUPPORT/HELP FOR LOCAL SCHOOL/COLLEGE STUDENTS. THROUGH SUCH LOVE IN ACTION THEY SEEK TO WITNESS TO THEIR FAITH IN JESUS CHRIST
