Trustees Report at a meeting held on November 6th 2021 at the Phoenix Centre

As a committee we are still striving to provide affordable facilities for the community of Alverthorpe as written in our constitution. We are slowly emerging from Covid although we are still maintaining some restrictions. Our users have remained loyal and we are really grateful to them.

The Drama group have extended their hours and Home Start have continued to pay rent as all their equipment is in storage at the centre. Wadsad have only recently returned as many of their members have health issues and are classed as vulnerable. There is another group that provides social activities for young adults with learning difficulties but at the moment they have chosen to wait a little longer before resuming their sessions. We also have a new group of cheerleaders who meet on two evenings per week. This means we have groups using the centre on five out of seven evenings. The Pre-school continues to meet weekdays for 38 weeks of the year but we should now be promoting the other facilities we have that could be used throughout the day even when the pre-school are open.

The council have continued to use the building for elections which is an easy way of boosting the finances. The pre - school staff have once again acted as caretaker and opened up for the election staff.

Because of the Covid restrictions we haven't been able to offer larger social events such as a Christmas fayre but hopefully when we produce our annual report next year things will be different,

However once again our main concern is the lack of committee members to help run the centre. Hopefully as the community become more confident getting out and about and mixing after Covid we can attract a few more helpers

Financial Report for the year ending September 30th 2021

At the end of this financial year we had a total of £30626 in the bank £13152 more than last year. We received £19750 in government grants to help us financially to get through the pandemic. This has been a lifeline for our group as it has enabled us to get on track with our maintenance programme and also provide the local authority with up to date health and safety documentation. One of the gas boilers has been replaced and there has been some redecoration done. We now have professionally written reports on water hygiene, fire safety procedures and an electricity safety report.

Our regular users have remained loyal and room hire income was £5930, only down £38 from last year.

We now need to build on this as we cannot rely on grants. Next year we are expecting a large increase in heating bills and we will have some difficult decisions to make about a possible increase in our hire charges that have not changed since we started over ten years ago.
