**INDEPENDENT CHARTERED CERTIFIED ACCOUNTANTS' REVIEW REPORT TO THE

We have reviewed the financial statements of Global Human Relief Ltd for the year ended 31 January 2024, which comprise the Income Statement, Balance Sheet and Notes to the Financial Statements. 
Conclusion
