**Objects:** 1.1.1 TO PROMOTE SUSTAINABLE DEVELOPMENT FOR THE BENEFIT OF THE PUBLIC IN PARTICULAR BY: 1.1.1.1 PROMOTING SUSTAINABLE CONSUMPTION AND PRODUCTION AND THE PRUDENT USE OF RESOURCES; AND 1.1.1.2 DEVELOPING AND PROMOTING SUSTAINABLE DESIGN AND MARKETING. "SUSTAINABLE DEVELOPMENT" MEANS "DEVELOPMENT WHICH MEETS THE NEEDS OF THE PRESENT WITHOUT COMPROMISING THE ABILITY OF FUTURE GENERATIONS TO MEET THEIR OWN NEEDS. 1.1.2 TO PROTECT AND PRESERVE THE ENVIRONMENT FOR THE PUBLIC BENEFIT IN PARTICULAR BY THE PROMOTION OF ZERO WASTE, WASTE REDUCTION, RECYCLING, SUSTAINABLE MATERIALS, RE-USE OF PRODUCTS, USE OF RECYCLED PRODUCTS AND THE USE OF SURPLUS. 1.1.3 TO ADVANCE THE EDUCATION OF THE PUBLIC IN SUBJECTS RELATING TO SUSTAINABLE DEVELOPMENT AND SUSTAINABLE WASTE MANAGEMENT (INCLUDING ALL ASPECTS OF WASTE GENERATION, WASTE MANAGEMENT, WASTE REDUCTION AND WASTE RECYCLING) AND THE PROTECTION, ENHANCEMENT AND REHABILITATION OF THE ENVIRONMENT AND TO PROMOTE STUDY AND RESEARCH IN SUCH SUBJECTS PROVIDED THAT THE USEFUL RESULTS OF SUCH STUDY ARE DISSEMINATED TO THE PUBLIC AT LARGE. 1.1.4 TO ADVANCE IN LIFE AND HELP YOUNG PEOPLE THROUGH PROVIDING SUPPORT AND ACTIVITIES WHICH DEVELOP THEIR SKILLS, CAPACITIES AND CAPABILITIES TO ENABLE THEM TO PARTICIPATE IN SOCIETY AS MATURE AND RESPONSIBLE INDIVIDUALS AS GLOBAL CITIZENS AND AS THE WORLD'S FUTURE LEADERS. 1.1.5 ANY OTHER OBJECT THAT IS EXCLUSIVELY CHARITABLE UNDER THE LAWS OF ENGLAND AND WALES. 1.2 THIS PROVISION MAY BE AMENDED BY SPECIAL RESOLUTION BUT ONLY WITH THE PRIOR WRITTEN CONSENT OF THE COMMISSION.
