THE OBJECTS THE FRIENDS SHALL HAVE THE FOLLOWING CHARITABLE OBJECTS: 3.1 TO PROMOTE FOR THE BENEFIT OF WILDLIFE AND OF THE PUBLIC (A) THE CONSERVATION AND PROTECTION OF WILDLIFE IN CHOPWELL WOODLAND PARK (THE PARK) AND (B) THE CONSERVATION PROTECTION AND IMPROVEMENT OF THE PARK'S PHYSICAL AND NATURAL ENVIRONMENT. 3.2 TO ADVANCE THE EDUCATION OF THE PUBLIC IN THE CONSERVATION AND PROTECTION OF WILDLIFE IN THE PARK AND IN THE CONSERVATION PROTECTION AND IMPROVEMENT OF THE PARK'S PHYSICAL AND NATURAL ENVIRONMENT. 3.3 TO PROVIDE OR ASSIST IN THE PROVISION OF FACILITIES AT THE PARK IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABILITY, FINANCIAL HARDSHIP OR SOCIAL CIRCUMSTANCES WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE.

Activities: We organise a variety of events and conservation tasks with the co-operation of Forestry England, and fund projects and improvements within Chopwell Wood. Work is carried out by a team of volunteers, both from our members and from the general public. We also produce information leaflets about the woodland and fund educational materials for use by visiting schools and other groups.
